City of Cincinnati An Ordinance No. 331

AUTHORIZING the transfer of the sum of \$574,760 within General Fund 050 from and to various operating accounts for the purpose of transferring the duties of Zoning Administration from the Department of Buildings and Inspections to the Department of City Planning and Engagement, in accordance with the attached Schedule of Transfer.

WHEREAS, the duties of Zoning Administration are being transferred from the Department of Building and Inspections ("B&I") to the Department of City Planning and Engagement; and

WHEREAS, the efficient oversight and integration of Zoning Administration, and the subordinate employees thereof, into the operations of the Department of City Planning and Engagement requires modification of the Administrative Code of the City of Cincinnati; and

WHEREAS, an ordinance will be presented to City Council amending the Administrative Code to reflect the transfer of duties associated with Zoning Administration from B&I to the Department of City Planning and Engagement; and

WHEREAS, funds need to be transferred to provide for the reassignment of these duties from B&I to the Department of City Planning and Engagement; now, therefore,

BE IT ORDAINED by the Council of the City of Cincinnati, State of Ohio:

Section 1. That the transfer of the sum of \$574,760 within General Fund 050 from and to various operating accounts according to the Schedule of Transfer, attached hereto and by this reference made a part hereof, is hereby authorized for the purpose of transferring the duties of Zoning Administration from the Department of Buildings and Inspections ("B&I") to the Department of City Planning and Engagement effective October 3, 2021.

Section 2. That the proper City officials are authorized to do all things necessary and proper to carry out the terms of Section 1 and the Schedule of Transfer attached hereto.

Section 3. That this ordinance shall be an emergency measure necessary for the preservation of the public peace, health, safety, and general welfare and shall, subject to the terms
