Subject: **Emergency Ordinance – Councilmembers Johnson and Parks FY 2023
Re-appropriation**

Transmitted herewith is an emergency ordinance captioned as follows:

AUTHORIZING the transfer and appropriation of the sum of \$12,218 from the unappropriated surplus of General Fund 050 to the City Manager’s Office General Fund non-personnel operating budget account no. 050x101x7400, effective July 1, 2022, for the purpose of providing one-time resources for the YWCA of Greater Cincinnati in fiscal year 2023; and **AUTHORIZING** the transfer and appropriation of the sum of \$6,500 from the unappropriated surplus of General Fund 050 to the City Manager’s Office General Fund non-personnel operating budget account no. 050x101x7400, effective July 1, 2022, for the purpose of providing additional one-time leveraged support funding for the St. Vincent de Paul Society’s Eviction Prevention Initiative in fiscal year 2023.

AUTHORIZING the transfer and appropriation of the sum of \$12,218 from the unappropriated surplus of General Fund 050 to the City Manager’s Office General Fund non-personnel operating budget account no. 050x101x7400, effective July 1, 2022, for the purpose of providing one-time resources for the YWCA of Greater Cincinnati in fiscal year 2023; and **AUTHORIZING** the transfer and appropriation of the sum of \$6,500 from the unappropriated surplus of General Fund 050 to the City Manager’s Office General Fund non-personnel operating budget account no. 050x101x7400, effective July 1, 2022, for the purpose of providing additional one-time leveraged support funding for the St. Vincent de Paul Society’s Eviction Prevention Initiative in fiscal year 2023.

WHEREAS, \$12,218 was included in the Approved FY 2022 Budget for Councilmember Parks’ office, which will return \$12,218 in General Fund resources to the unappropriated surplus at the end of fiscal year 2022; and

WHEREAS, Council wishes to provide one-time resources in the amount of \$12,218 for the YWCA of Greater Cincinnati in fiscal year 2023; and

WHEREAS, \$6,500 was included in the Approved FY 2022 Budget for Councilmember Johnson’s Office, which will return \$6,500 in General Fund resources to the unappropriated surplus at the end of fiscal year 2022; and

WHEREAS, Council wishes to provide resources in the amount of \$6,500 for additional one-time leveraged support funding for the St. Vincent de Paul Society’s Eviction Prevention Initiative in fiscal year 2023; now, therefore,

BE IT ORDAINED by the Council of the City of Cincinnati, State of Ohio:

Section 1. That the sum of \$12,218 is hereby transferred and appropriated from the unappropriated surplus of General Fund 050 to the City Manager’s Office General Fund non-personnel operating budget account no. 050x101x7400, effective July 1, 2022, for the purpose of providing one-time resources for the YWCA of Greater Cincinnati in fiscal year 2023.

Section 2. That the sum of \$6,500 is hereby transferred and appropriated from the unappropriated surplus of General Fund 050 to the City Manager’s Office General Fund non-

personnel operating budget account no. 050x101x7400, effective July 1, 2022, for the purpose of providing additional one-time leveraged support funding for the St. Vincent de Paul Society's Eviction Prevention Initiative in fiscal year 2023.

Section 3. That the proper City officials are hereby authorized to do all things necessary and proper to carry out the terms of Sections 1 and 2 hereof.

Section 4. That this ordinance shall be an emergency measure necessary for the preservation of the public peace, health, safety, and general welfare and shall, subject to the terms of Article II, Section 6 of the Charter, be effective immediately. The reason for the emergency is the immediate need to make these funds available in fiscal year 2023 and to ensure that contracts related to these funds can be executed promptly.
