So now the boys got their toys - the streetcar will run - so now what are we the citizens going to get - it certainly is not sleep and certainly not peace and quiet - and at the end of the day, I cannot be more upset that councilmembers pay no attention to their constituents' correspondence. I had no idea that you each have aides whose job it is to screen your mail and never contact the person who did the original contacting - they are just ignored. Mayor Cranley did reply and has even attended meetings on this problem - so where are the rest of you? If you were a company that I wanted to do business with, I would just move on and give my business to someone else. But you guys are guaranteed a job for at least one more year - for those who are term limited - and then you move on. Occasionally you get a reply email - as I did below - but again there is no follow through. The Cincinnati Enquirer couldn't even get your attention for the motorcycle problem in this city when they ran a story on it showing that the problem has been going on for years - I personally have been involved for 5 years. Bet this problem has been going on longer than the streetcar fight has been. So pretend that the bikes are streetcars that are not wanted on the streets by the neighbors, but you do, so you can then at least reply or even act on it by letting us know what you can and will do about it. ! don't want to be rude but after five years, there is no patience left and I never really had any to begin with. In the Walnut Hills/Eden Park case, the park board shut down Twin Lakes to vehicular traffic and then a group was formed to oppose it, and it was opened again. None of the folks who were part of that group live in this area and yet they were paid attention to because they said they were going to hold a press conference. No one contacted us checking to see if we had another answer - we did - to close Twin Lakes to vehicular traffic earlier than the scheduled 10 pm closing time, e.g., 6 pm. The park board has been great in working with us, but it is not their problem and they are trying the best they can with a limited budget to keep the parks as one of Cincinnati's real treasures. And as for the councilmembers who replied to an email re the closing and said they were on the side of closing to vehicular traffic; we did not hear from them again when it was reopened. Do any of the bike riders ride in their own neighborhoods at all hours of the day and night?

All we have asked for from city council - and in particular from the chairs of the law and neighborhood committees - is to hold a meeting/hearing so you can hear what the people who live in this city have to live with and so they can have the answers as to why city council will not take this seriously.

To all members of council: please answer this email and tell us what we must do to make this happen. And for the others who are receiving this email, please give us your thoughts on this.
