RECOGNIZING Sharon Coolidge and **EXPRESSING** the appreciation of the Mayor and the Council of the City of Cincinnati for Sherry and her eleven-year career reporting on Cincinnati City Hall for The Cincinnati Enquirer.

WHEREAS, Sharon Coolidge, or Sherry to everyone who knows her, grew up in Boardman, Ohio, the daughter of public-school teachers John and Georgia Turco, and the older sister of Michael Turco, a public-school teacher in Texas; and

WHEREAS, Sherry graduated from Boardman High School in 1991, where she was the co-editor of the school newspaper, The Bugle, with her lifelong best friend, Tom Yatsco; and

WHEREAS, Sherry graduated from Bowling Green State University in 1995, where she worked for The BG News and, as an Alpha Phi, was editor of the Greek life newspaper, The Gavel; and

WHEREAS, Sherry has a thirty-year career in public service as a journalist, 22 of those years spent in Cincinnati; and

WHEREAS, Sherry's first job was as a police reporter for The Lorain Morning Journal in Northeast Ohio from 1995 to 1998; and

WHEREAS, Sherry moved to Fort Myers, Florida to work at The News-Press, where she fell in love with her co-worker and now-husband Alexander Coolidge, while covering the Thomas Edison Parade; and

WHEREAS, Sherry and Alexander Coolidge moved to Cincinnati in 2002 to work at The Cincinnati Enquirer, married the following year, and had son Jack in 2008; and

WHEREAS, Sherry covered Hamilton County Courts, Cincinnati Police, Hamilton County Government, and, for the last eleven years, Cincinnati City Hall; and

WHEREAS, in that time, Sherry has written thousands of stories and won numerous state and national awards for reporting that have made our community a better place to live, work, and raise a family; and

WHEREAS, Sherry championed public record laws so the community could have a better understanding of their elected leaders; and

WHEREAS, notably, Sherry wrote the special report "Lead's Dangerous Legacy," garnering an Associated Press Society of Ohio First Amendment Award and prompting the City to prosecute landlords who poisoned children; and

WHEREAS, Sherry chronicled a year in the life of the children and educators at Ethel M. Taylor Academy in Cincinnati, helping prompt the creation of the Cincinnati Poverty Collaborative; and

WHEREAS, Sherry was part of the Cincinnati Enquirer team that won a Pulitzer Prize in 2018 for "Seven Days of Heroin," the story of one typical and terrible week in an epidemic that often went unnoticed, even as it destroyed lives every day; and

WHEREAS, Sherry was the first reporter to correctly identify Leelah Alcorn, a 17-yearold transgender girl whose suicide attracted international attention for her note that said, "[t]he only way I will rest in peace is if one day transgender people aren't treated the way I was[;] [t]hey're treated like humans, with valid feelings and human rights"; and

WHEREAS, Sherry uncovered corruption at City Hall and informed citizens about the behavior of their elected leaders behind closed doors; and

WHEREAS, the Associated Press Society of Ohio named Sherry Best News Writer in 2014, 2015, and 2023; and

WHEREAS, Sherry will continue a career in public service working for the Hamilton County Prosecutor's Office; now, therefore,

BE IT RESOLVED by the Council of the City of Cincinnati, State of Ohio:

Section 1. That the Mayor and this Council recognize Sharon Coolidge for her eleven-year career spent reporting on Cincinnati City Hall for The Cincinnati Enquirer.

AMENDING Ordinance No. 99-2023 to increase the amount of funding the City Manager is authorized to accept from the Surface Transportation Block Grant Program (ALN 20.205) awarded through the Ohio-Kentucky-Indiana Regional Council of Governments, from \$1,199,998 to \$1,325,370 and to appropriate the additional \$125,372 to existing capital improvement program project account no. 980x232x222355, "Wasson Way Federal STBG 2022," to provide additional resources to complete the Wasson Way Trail project.

Approval of this Ordinance will amend Ordinance No. 0099-2023 to increase the amount of funding the City Manager is authorized to accept from the Surface Transportation Block Program ("STBG") (ALN 20.205) awarded through the Ohio-Kentucky-Indiana Regional Council of Governments ("OKI"), from \$1,199,998 to \$1,325,370. This Ordinance will also appropriate the additional amount of \$125,372 to existing capital improvement program project account no. 980x232x222355, "Wasson Way Federal STBG 2022," to provide additional resources to complete the Wasson Way Trail project.

On March 29, 2023, the City Council approved Ordinance No. 0099-2023, authorizing the City Manager to accept and appropriate additional OKI STBG resources in an amount up to \$1,199,998 to capital improvement program project account no. 980x232x222355, "Wasson Way Federal STBG 2022," for the purpose of providing additional resources to complete the Wasson Way Phase 6A project. Additional construction needs were identified during the construction of the Wasson Way project. The City of Cincinnati requested, and OKI awarded, an additional \$125,372 to complete the project.

Acceptance of the increased grant award requires a 25 percent local match, which will be provided from existing Wasson Way Trail capital improvement program project accounts 980x232x232371, 980x232x242371, and 980x232x252371. This grant does not require new FTEs/full time equivalents.

The Administration recommends passage of this Ordinance.

WHEREAS, on February 9, 2022, Council approved Ordinance No. 25-2022, authorizing the City Manager to accept and appropriate grant resources totaling \$1,667,595 from the Ohio-Kentucky-Indiana Regional Council of Governments ("OKI") Surface Transportation Block Grant Program ("STBG") to capital improvement program project account no. 980x232x222355, "Wasson Way Federal STBG 2022"; and

WHEREAS, on March 29, 2023, Council approved Ordinance No. 99-2023, authorizing the City Manager to accept and appropriate additional OKI STBG resources of up to \$1,199,998 to capital improvement program project account no. 980x232x222355, "Wasson Way Federal STBG 2022," to provide additional resources to complete the Wasson Way Phase 6A project; and

WHEREAS, additional construction needs were identified during the construction of the Wasson Way project, and the City requested, and OKI awarded, an additional \$125,372 to complete the project; and

WHEREAS, the OKI STBG grant requires a 25 percent local match, which will be provided from existing Wasson Way Trail capital improvement program project accounts 980x232x232371, 980x232x242371, and 980x232x252371; and

WHEREAS, there are no new FTEs/full time equivalents associated with this grant; and

WHEREAS, Ordinance No. 99-2023 must be amended to increase the grant amount in order for the City to accept and appropriate additional funding for the Wasson Way Trail project; now, therefore,

BE IT ORDAINED by the Council of the City of Cincinnati, State of Ohio:

Section 1. That Section 1 of Ordinance No. 99-2023, approved by Council on March 29, 2023, is amended as follows:

Section 1. That the City Manager is hereby authorized to accept and appropriate additional Surface Transportation Block Grant ("STBG") (ALN 20.205) resources awarded from an existing Ohio-Kentucky-Indiana ("OKI") Regional Council of Governments grant in an amount up to \$1,199,998 \$1,325,370 to existing

capital improvement program project account no. 980x232x222355, "Wasson Way Federal STBG 2022," for the purpose of providing additional resources to complete the Wasson Way Phase 6A project (PID 112894).

Section 2. That all terms of Ordinance No. 99-2023 not amended in this ordinance remain in full force and effect.

Section 3. That this ordinance shall take effect and be in force from and after the earliest period allowed by law.

WE MOVE that, within 90 days, the Cincinnati Parks Department and Cincinnati Recreation Commission (CRC) evaluate the Futures Commission's proposal for transferring the management of the 954 acres of greenspace currently under CRC to Cincinnati Parks, including any implications for staffing, equipment, potential cost savings, and the ability of CRC to focus on managing recreation centers and continue to deliver best-in-class programming.

STATEMENT

The Futures Commission recommended that Cincinnati Parks and CRC explore shared services opportunities, which they indicated would yield an estimated \$25 million in savings over 10 years. That the City Manager is authorized to apply for, accept, and appropriate a grant of up to \$15,881 from the Ohio Environmental Protection Agency Mosquito Control Grant Program to investigate the prevalence of mosquito vectors and the incidence of infection in the mosquito populations, to identify density locations for mosquito vector species, and to educate communities in the immediate area on how to reduce the mosquito populations.

Section 2. That the Director of Finance is authorized to deposit the grant funds into Public Health Research Fund revenue account no. 350x8536.

Section 3. That the proper City officials are authorized to do all things necessary and proper to carry out the terms of the grant and Sections 1 and 2.

WHEREAS, the Southwest Ohio Regional Transit Authority ("SORTA") is designing and constructing a bus rapid transit system in and through the City of Cincinnati; and

WHEREAS, the Cincinnati Municipal Code currently provides for bus stops in the public right-of-way but does not provide for separate bus rapid transit zones in the public right-of-way; and

WHEREAS, the City and SORTA have a strong interest in promoting and protecting the safety and welfare of the traveling public by designating areas for the bus rapid transit system; and

WHEREAS, Council wishes to provide for the designation of bus rapid transit zones and to ensure these zones promote the safe and efficient operation of the bus rapid transit system; now, therefore.

BE IT ORDAINED by the Council of the City of Cincinnati, State of Ohio:

Section 1. That new Section 723-77, "Trespass in a Designated Bus Rapid Transit Zone," of Chapter 723," Streets and Sidewalks, Use Regulations," of the Cincinnati Municipal Code is hereby ordained to read as follows:

Sec. 723-77. – Trespass in a Designated Bus Rapid Transit Zone.

No person shall enter or remain upon, occupy, or use a designated bus rapid transit zone established pursuant to Section 723-26 of this Chapter for purposes other than boarding or deboarding a bus rapid transit vehicle, waiting for a bus rapid transit, or purchasing a fare. A person is in violation of this section only after having occupied a designated bus rapid transit zone for a period of time that exceeds that which is necessary to purchase a fare and to wait for, board, or deboard a bus rapid transit vehicle. It shall be prima facie evidence of a violation of this section if a person remains in a designated bus rapid transit zone after two bus rapid transit vehicles stop and the person does not board either of the bus rapid transit vehicles.

A person violating this section shall be guilty of a misdemeanor of the fourth degree and shall be fined not more than \$250 or imprisoned not more than 30 days, or both.

Section 2. That existing Section 723-26, "Designated Streetcar Transit Zones," of Chapter 723, "Streets and Sidewalks, Use Regulations," of the Cincinnati Municipal Code is hereby amended to read as follows:

Sec. 723-26. - Designated Streetear Transit Zones.

- (a) Streetcar Transit Zones. The Director of the Department of Transportation and Engineering may designate a streetcar station platform located in the public right-of-way as a designated streetcar transit zone, which area shall be accessible exclusively by persons for the limited purposes of boarding or deboarding a Cincinnati streetcar vehicle, waiting to board a Cincinnati streetcar vehicle, or purchasing a fare. Designated streetcar transit zones shall be clearly marked and contain readily visible signage indicating "Streetcar Transit Zone" or other similar notification.
- (b) Bus Rapid Transit Zones. The Director of the Department of Transportation and Engineering may designate a bus rapid transit station platform located in the public right-of-way as a designated bus rapid transit zone, which area shall be accessible exclusively by persons for the limited purposes of boarding or deboarding a bus rapid transit vehicle, waiting to board a bus rapid transit vehicle, or purchasing a fare. Designated bus rapid transit zones shall be clearly marked and contain readily visible signage indicating "Bus Rapid Transit Zone" or other similar notification.

DECLARING that Windsor Street at Gilbert Avenue in the Walnut Hills neighborhood shall hereby receive the honorary, secondary name of "Larry A. Donald Way" in honor of Larry A. Donald, and in recognition of his contributions to the Cincinnati community and the sport of boxing.

WHEREAS, Larry ("the Legend") Donald was born and raised in the Avondale neighborhood of Cincinnati, and grew up playing basketball at the Cincinnati Academy of Physical Education; and

WHEREAS, Mr. Donald took up boxing when he was twenty years old and went from sparing with longtime friend Molecule to becoming a two-time Ohio State Fair Champion; and

WHEREAS, Mr. Donald boxed in the super-heavyweight division and won many accolades and awards including the National Golden Glove Champion in 1989 and 1990; was the 1991 ABF USA National Amateur Champion; won the gold medal at the United States Olympic Festival in 1989 and 1990; and a Silver Medal at the 1990 Goodwill Games; and

WHEREAS, Mr. Donald continued to represent the United States and the City of Cincinnati on the world stage by participating in three Amateur World Championships where he won Silver Medal in 1990 and Bronze Medal in 1991 and won the world Amateur Boxing Championship in 1992; and

WHEREAS, Mr. Donald represented the United States as a super heavyweight at the 1992 Summer Olympic Games in Barcelona; and

WHEREAS, in 1993, Mr. Donald defeated Jeremy Williams for the WBC Continental American Championship, which was the last fight broadcasted on ABC's Wide World of Sports on March 12, 1994; and

WHEREAS, Mr. Donald continued his boxing career including winning fights for heavyweight titles for the Latino WBO NABO Championship on June 2, 1996; the WBC Continental Americas on April 8, 1997; and the WBO NABO Championship on February 29, 2000; and

WHEREAS, in 2004, Mr. Donald won every round against Evander Holyfield to win the North America Boxing Council heavyweight title at Madison Square Garden in New York City; and

WHEREAS, as an amateur, Mr. Donald had 72 fights with a record of 67 wins and five losses, and as a professional had a record of 42 wins with 24 knockouts, five losses, and three draws; and

WHEREAS, in 2023, Mr. Donald was inducted into the Indiana Boxing Hall of Fame and in 2024 was inducted into the Rochester, New York Boxing Hall of Fame; and
