




Demographics: Compliance Achieved Dismissals

Compliance Achieved (Race)




Compliance Achieved (Sex)






Demographics: Property Transfer Dismissals





Property Transfer (Sex)





Demographics: Sentence Imposed









Demographics: Jail Time Served






Jail Sentence(Sex)






Demographics: EMU Imposed





Delhi Avenue Prosecutions

- Investor/speculator purchased in 2001; owned nearly 2/3 of Sedamsville
- History of transferring property to avoid compliance
- Ordered kept vacant since 2005
- Multiple notices and civil fines from 2001 2018, no compliance
- January 2019: Criminal prosecution initiated
- No contest plea
 - 180-day sentence suspended + costs + probation
 - Served 30 days on probation violation



3500 Lumford (20/CRB/22826)







3500 Lumford (20/CRB/22826)

- 2013: Investor/speculator purchased vacant school,
- 2017: property becomes vacant; unsecured
- 2017-22: structure has been subject of fire, repeatedly vandalized by trespassers, chronic dump site, known attractive nuisance to area children
 - Repeated orders/citations/barricades/lot abatements
 - Currently subject to demolition
- 2022: Port o/b/o Kennedy Heights community offers \$400k to purchase; declined and sold to LLC for \$150k
- July 2022: Guilty plea: 90 day, 60 days suspended, 30 days imposed; 200 hours community service: allowed to move abroad



8361 Mace (18/CRB/22826)







8361 Mace (18/CRB/22826)

- 2010-18: regular complaints regarding junk cars and littered lots
 - City incurred over \$8,000 in costs abating conditions over this time
 - Condemned property, subject to demolition; illegally occupied
- July-August 2018: property referred to Quality of Life
 - CERT property
 - Administrative warrant
 - Neighbors contact Fox 19 regarding exterior hoarding



8361 Mace (18/CRB/22826)

- August 2018: criminal complaint initiated; not served until January 2019 due to evasion of Police
 - City repeatedly abates property during prosecution
- June 2019: Plea of no contest
- Sentence:
 - 6 months probation
 - Court costs
 - Keep property compliant
- September 2019: Property not in compliance
- November 2019: Probation violation
 - Jail sentence imposed; Mitigated in January 2020- EMU
- Present: Property remains not in compliance; PBV capias



1921 Elm (17/CRB/19143)






1921 Elm (17/CRB/19143)

- Investor purchased in 2014, subject to orders
- 2015: building debris falling into right-of-way
- July 2017: criminal prosecution initiated
- August 2017: fire at property
- February 2018: plea of guilty: 180 days, suspended, 180 days probation, with timeline for compliance, and EMUF
- February–July 2018: Multiple extensions for compliance provided
 - City performs barricades during this period
- July 2018: EMU terminated
- January 2020: cited for probation violation
- August 2020: guilty of probation violation: 90-day sentence



3725 Reading Road (19/CRB/23464)







3725 Reading Road (19/CRB/23464)

- Investor purchased in 2007, subject to orders
- Enforcement begins in 2013; investor acknowledged orders
- Final Notice issues 2016, no compliance to date
- 2017: tax delinquent; tax lien
- December 2017: first civil fine issues; no compliance
- January 2019: second and third civil fines issue; no compliance
- Criminal case filed 9/16/2019



3725 Reading Road (19/CRB/23464)

- Defendant entered no contest plea
 - 180 suspended sentence + probation
 - EMU 100 days
- Property remains noncompliant
- Tax delinquent since 2017 (exceeds \$7k)
- Investor owns 8 investment properties, all delinquent
- City has repeated barricaded when standing open
- Historic; demolition not viable



3703 Glenway (21/CRB/5354)









3703 Glenway (21/CRB/5354)

- Investor purchased in 2015
 - Improperly uses vacant structure and accessory structure for storage, including storage of hazardous waste
- 2015-present: dozens of complaints from community
 - Multiple orders and civil citations fail to result in compliance
- February 2021: prosecution initiated
- December 2021: convicted and sentenced to time served; 180 days probation; 2 years of EMU
 - Probation violation noted last month; pending











654 Neave (19/CRB/20759)

- Investor controlled since 2011: multiple property transfers
- 2012-2021:
 - 7 City-led lot abatements
 - 8 barricades
 - Multiple orders and civil fines
- August 2019: criminal prosecution initiated
- September 2020: convicted: 180 days suspended; 180 days probation; 100 days EMU
 - June 2021: Probation terminated



Property Transfers

- Total Transfers: 69
 - Time of transfer not reflected; often multiple transfers
 - Transfers to self/defendant-owned LLCs
 - Transfers prior/during pendency; prior to appearing in court
 - Transfers pursuant to civil settlement agreement
- Transfers to Landbank: 4 (current ownership)



Policy Considerations

- Criminal prosecution occurs after other efforts exhausted
- These investors/speculators allowing properties to deteriorate
 - Goal = increase housing supply
- Impact on community, neighbors, public safety
- The Landbank is a property owner of last resort
