## STATEMENT

The COVID-19 pandemic has had a destructive impact on our economy, our communities, and our children and families. It has exasperated existing inequities and forged new ones; decimated businesses, organizations, and nonprofits; and, forced beloved aspects of our City to be stymied for our collective greater health. The past year served as a reminder of the critical role government plays in keeping communities afloat.

As we move forward toward recovery, Cincinnati has been given a wonderful opportunity. The federal funds we will receive from the American Rescue Plan could help our city not only recover from the pandemic, but grow into a more equitable, sustainable, and economically viable community for all. To achieve this, we must give each distribution of this funding the weight it deserves.

Over the past month, Council has engaged with the community, consulted with experts and local leaders, and Councilmembers have submitted several proposals for where funding should go, per our personal priorities and the priorities of constituents. As we currently come together to find consensus for Year 1 spending, I hope this Omnibus Motion can act as a starting point for conversations regarding Year 2 spending. We should look to next year's spending as a pathway to get longer-term fiscal relief to those who need it, especially those who may have not received ARP Funding in Year 1.
