Findings:	Officers conducted an inspection at the Dusmesh restaurant for the application of a D1 and D2 liquor permit. The restaurant is not set up for a class D liquor permit. The equipment and fixtures on the premises are not set up or hooked up with a three-compartment sink or commercial automatic dishwasher. There isn't any areas setup in the restaurant for alcohol storage. The coolers and freezers were unsanitary throughout the restaurant having spilled food at the bottom of them that appeared to have been sitting for a period of time. The floors throughout the restaurant and kitchen were sticky and full of clutter and debris. The basement dry food storage area had evidence of rodent feces on the floor.

REASON FOR OBJECTION:

The restaurant does not conform to building, safety, and health requirements. The restaurant has pending citations with the Health Department and Building and Inspection. The restaurant has an unfavorable record with prior liquor inspection

Officers previously conducted a liquor inspection on 02/22/22 at the Dushmesh restaurant. The disposition of the inspection was a that the restaurant was operating under unsanitary conditions. The City of Cincinnati Health Department was notified and conducted a health inspection at the location. The restaurant was cited for several health code violations. There was evidence that the applicant was using alcohol by the odor of alcohol on his breath during the inspection and the evidence of empty beer cans in the rear of the restaurant. The owner was observed with two beer bottles in his hand when police arrived, he tried to quickly discard those alcoholic beverages when he noticed police on scene. The restaurant did not conform to building safety and health requirements.

Therefore, the City requires such time extension in order to perform its due diligence in this matter.
