An Ordinance No. 269

-2022

ESTABLISHING new capital improvement program project account no. 980x232x232365, "Central Pkwy Bikeway Ph2 PID 114326 TA Grant," for the purpose of providing resources for the construction of the second phase of the Central Parkway Bikeway; **AUTHORIZING** the City Manager to accept and appropriate a Transportation Alternatives grant (ALN 20.205) in the amount of up to \$750,000 awarded by the Ohio-Kentucky-Indiana Regional Council of Governments to the newly established capital improvement program project account no. 980x232x232365, "Central Pkwy Bikeway Ph2 PID 114326 TA Grant," for the purpose of providing resources for the second phase of the Central Parkway Bikeway project; **AUTHORIZING** the Director of Finance to deposit the grant resources into newly established capital improvement program project account no. 980x232x232365; and further **AUTHORIZING** the City Manager to do all things necessary to cooperate with the Director of the Ohio Department of Transportation to complete the Central Parkway Bikeway project.

WHEREAS, on June 19, 2019, City Council approved Ordinance No. 0241-2019, authorizing the City Manager to apply for the Transportation Alternatives ("TA") grant (ALN 20.205) in an amount of up to \$750,000 awarded by the Ohio-Kentucky-Indiana Regional Council of Governments; and

WHEREAS, Council approval is necessary for acceptance of the TA grant funds; and

WHEREAS, local matching resources of up to \$2,739,130.57 are required for the grant, which will come from existing capital improvement program project account nos. 980x233x192346, "Central Parkway Bikeway," 980x232x222358, "Central Parkway Bicycle Facility Phase 2," and 980x232x222357, "Bicycle Transportation Program"; and

WHEREAS, no new FTEs are associated with the acceptance of this grant; and

WHEREAS, constructing bicycle lanes is in accordance with the "Connect" goal to "[d]evelop an efficient multi-modal transportation system that supports neighborhood vitality" as well as the strategy to "[e]xpand options for non-automotive travel," as described on pages 129-134 of *Plan Cincinnati* (2012); now, therefore,

BE IT ORDAINED by the Council of the City of Cincinnati, State of Ohio:

Section 1. That Council hereby authorizes the establishment of new capital improvement program project account no. 980x232x232365, "Central Pkwy Bikeway Ph2 PID 114326 TA

Grant,” for the purpose of providing resources for the construction of the second phase of the Central Parkway Bikeway.

Section 2. That the City Manager is hereby authorized to accept and appropriate Transportation Alternatives grant resources (ALN 20.205) in the amount of up to \$750,000 awarded by the Ohio-Kentucky-Indiana Regional Council of Governments to the newly established capital improvement program project account no. 980x232x232365, “Central Pkwy Bikeway Ph2 PID 114326 TA Grant,” for the purpose of providing resources for the second phase of the Central Parkway Bikeway.






Section 5. That the proper city officials are hereby authorized to do all things necessary to implement Sections 1 through 4 hereof.
