### **STATEMENT**

Since full virtual participation has been allowed for, and at times required, due to the COVID-19 pandemic over the past year, we have seen both the need and desire for this option to be allowed in the future.

The option for a councilmember to participate in meetings virtually should be available when special sessions are scheduled, when s/he is sick, when s/he is caring for a sick family member, or for any other personal reason.

These measures can also allow for greater public participation, as many people who may want to speak before council are unable to do so for personal or work related reasons, and our city has a duty to provide such access to the public.
