# **INITIATIVE PETITION**

#### NOTICE:

Whoever knowingly signs this petition more than once, signs a name other than his own, or signs when not a legal voter is liable to prosecution.

(See §731.33 of the Ohio Revised Code)

To the City Clerk of the City of Cincinnati, Ohio and Hamilton County, Ohio Board of Elections: Pursuant to Ohio Revised Code §3519.01(A), the undersigned electors of the State of Ohio, numbering in excess of 10% of electors in this municipal corporation who voted for governor in the last election, hereby submit to you the full text of proposed ordinances for the City of Cincinnati, Hamilton County, Ohio, hereby sought to be submitted to a citywide initiative vote, and a summary of the proposed initiative.

To be submitted to the electors for their approval or rejection.

### TITLE

An initiative petition to submit to the voters of Cincinnati for their approval or rejection the following proposed ordinances in their entirety, which would make certain revisions by amendment to the Codified Ordinances of the City of Cincinnati, Ohio Ordinance Nos. 708-26, 708-27, and 708-28.

#### **SUMMARY**

This initiative petition would submit to a citywide initiative vote the question of the approval or rejection of the Proposed Ordinances, which contains the following summarized changes to the City of Cincinnati's hunting laws as it relates to hunting deer on Cincinnati Park Board property and on Hamilton County Park District Property located within the City of Cincinnati.

The Proposed Ordinances repeal provisions of the Codified Ordinances of the City of Cincinnati, Ohio relating to laws concerning the hunting of deer on Cincinnati Park Board property and on Hamilton County Park District Property located within the City of Cincinnati. It further enacts a new provision of the Codified Ordinances of the City of Cincinnati, Ohio related to humane euthanasia of an animal on Cincinnati Park Board property and on Hamilton County Park District Property located within the City of Cincinnati. Specifically:

- 1. To repeal Ordinance No. 708-26, excluding Section 708-26(A), which permits the discharge of weapons on Cincinnati Park Board property and on Hamilton County Park District Property located within the City of Cincinnati for the purpose of hunting deer.
- 2. To amend Section 708-26(A) of Ordinance No. 708-26, to prohibit the Public Recreation Commission or the Director of Recreation from permitting archery on Cincinnati Park Board property and on Hamilton County Park District Property located within the City of Cincinnati for the purpose of hunting animals.

- 3. To amend Ordinance No. 708-27 by repealing section 708-27(c)(7), which permits the discharge of weapons on Cincinnati Park Board property and on Hamilton County Park District Property located within the City of Cincinnati for the purpose of hunting deer.
- 4. To amend Ordinance No. 708-27 by adding new section 708-27(c)(9), to permit the discharge of weapons on Cincinnati Park Board property and on Hamilton County Park District Property located within the City of Cincinnati for the purpose alleviating the pain or suffering of an animal where there is no other reasonable remedy or relief and requiring that such discharge be immediately reported to a law enforcement officer of the political subdivision.
- 5. To repeal Ordinance No. 708-28, which permits the discharge of weapons pursuant to Ordinance No. 708-26 for the purpose of hunting.

#### PROPOSED ORDINANCES

Be it Resolved by the People of the City of Cincinnati, Ohio that Codified Ordinances of the City of Cincinnati, Ohio Ordinance Nos. 708-26, 708-27, 708-28 are hereby amended to add and repeal language as shown below. New language is underlined, repealed language is struck through, and unchanged language appears without underline or strikethrough.

# The following is a full and correct copy of the text of the Proposed Ordinances:

Sec. 708-26. — Permitted Hunting on Cincinnati Park Board Property and on Cincinnati Park Board property and on Hamilton County Park District Property located within the City of Cincinnati.

The Cincinnati Park Board has the authority to permit the legal use and discharge of weapons within Cincinnati Parks in compliance with State of Ohio game and hunting laws, in order to control the deer overpopulation that is destroying the urban forest. Permitted use is governed by the rules of the Board of Park Commissioners of the City of Cincinnati.

The hunting of deer under the authority of the Hamilton County Park District for the purpose of controlling the deer overpopulation in the urban forest shall be permitted on Hamilton County Park District Property located in City of Cincinnati provided that the Hamilton County Park District takes all necessary action to fully comply with all State of Ohio game and hunting laws regarding such deer hunting activities and provided that all permitted hunters receive any and all required training to engage in such activities in accordance with such State of Ohio game and hunting laws. Permitted use is governed by of the rules of the Board of Park Commissioners of the City of Cincinnati. At least fourteen days prior to engaging in any deer hunting activities on Hamilton County Park District Property, the executive director of the Hamilton County Park District or his or her designee shall provide written notice to the city manager describing the days, hours and location of any such deer hunting activities on Hamilton County Park District properties and the number of permitted hunters engaged in each such deer hunting activity and shall further provide documentation establishing compliance with State of Ohio game and hunting laws for each deer hunting activity.

#### Repealed.

Sec. 708-26A. - Permitted Archery Programs.

A person may lawfully discharge a bow and arrow approved by the Public Recreation Commission or the Director of Recreation when participating in an archery program <u>for purposes other than the hunting of animals</u> approved by the Public Recreation Commission or the Director of Recreation which program occurs on property owned by the City of Cincinnati.

Sec. 708-27 - Discharging Firearms.

- (a) No person shall discharge any kind of firearm or dangerous weapon, including handguns, rifles, air rifles or air guns by whatever name known.
- (b) No person shall discharge any cannon or explosive bomb from a mortar.
- (c) Section (a) of this ordinance shall not apply to:
- (1) Any law enforcement officer, any agent, or employee of this or any other political subdivision or the United States if acting within the scope of his duties.
- (2) Any member of the Armed Forces of the United States or any state militia if acting within the scope of his duties.
- (3) Any person acting pursuant to Section 708-23.
- (4) Any employee of the Cincinnati Zoo and Botanical Garden, acting within the scope of his employment, on the Zoo's property and who is currently authorized to discharge a firearm by the Chief of Police.
- (5) Any individual both authorized by the Chief of Police and licensed as a private police officer pursuant to Chapter 857 of the Municipal Code who is acting within the scope of his duties as a private police officer.
- (6) Any person acting in self defense.
- (7) Any person lawfully engaged in the Park Board hunting program using approved weapons as authorized by Section 708-26.
- (8) (7) Any person lawfully engaged in an archery program approved by the Public Recreation Commission or the Director of Recreation on property owned by the city of Cincinnati and using approved bows and arrows as authorized by Section 708-26A.
- (98) Any person lawfully engaged in remote chemical immobilization of deer using an airpowered gun as a component of a deer fertility control study authorized by the Board of Park Commissioners and authorized by a permit issued by the Ohio Department of Natural Resources, Division of Wildlife.
- (9) Any person on Cincinnati Park Board Property or on Hamilton County Park District Property located within the City of Cincinnati who is acting on an emergency basis to alleviate the pain or suffering of an animal where there is no other reasonable remedy or relief. Discharge of a weapon for this purpose must immediately be reported to a law enforcement officer of this political subdivision.

#### Sec. 708-28. - Permitted Hunting Firearms.

All equipment used pursuant to Section 708-26 herein must conform to State of Ohio requirements. Compound, long, recurve and crossbows are allowed. In order to use a longbow there must be a minimum draw weight of 40 pounds. In order to use a crossbow there must be a minimum draw weight of 75 pounds and a maximum draw weight of 200 pounds.

This letter is in response to your May 13, 2024 correspondence to the Clerk of Council pertaining to a proposed initiative petition. In its current form, the proposed initiative petition does not comply with the requirements set forth in the Charter of the City of Cincinnati ("Charter").

Per the Charter, Article II, Section 8(A)(1), petitioners must use the forms provided by the Ohio Secretary of State for an initiated ordinance. The proper form that must be used is number 6-I, available at https://www.ohiosos.gov/elections/elections-officials/forms-petitions/. Additionally, it is not permissible for an initiative petition to contain a Summary section. Article II, Section 8(A)(1)(e) of the Charter specifies that "[a] petition shall contain a full and correct copy of any proposed ordinance . . . with no summary, argument, or other ancillary information regarding the proposal placed thereon..."

A revised proposed initiative petition may be resubmitted to the Clerk of Council at clerkofcouncil@cincinnati-oh.gov. If you have any questions regarding this matter, please contact me.
