On October 11, 2023, a complete Local Historic Landmark designation application was submitted to the Department of City Planning for the St. Leo the Great School Building by 2569 St. Leo, LLC. According to the Cincinnati Zoning Code, an application for the designation of a Local Historic Landmark shall be forwarded to the City Planning Commission following a public hearing of the Historic Conservation Board.

On December 4, 2023, the Historic Conservation Board (HCB) held a public hearing on the Local Historic Landmark designation application. A majority of board members present throughout the hearing and constituting a quorum, voted to recommend the St. Leo the Great School Building to the City Planning Commission and City Council for approval.

The City Planning Commission voted unanimously to approve and forward the application to City Council after considering the relationship of the proposed designation to the comprehensive plans of the city and of the community in which the proposed Historic Landmark is located; the effect of the proposed designation on the surrounding areas and economic development plans of the city; and other planning and historic preservation considerations.

The City Planning Commission recommended the following on January 5, 2024 to City Council:

APPROVE the proposed designation of St. Leo The Great School Building as a Local Historic Landmark at 2569 St. Leo Place in North Fairmount under Criterions 1 and 3 of the Cincinnati Zoning Code (§1435-07-1a); and

ADOPT the conservation guidelines.
