An Ordinance No. 507

ESTABLISHING new capital improvement program project account no. 980x233x222390, "Red Bike Program Expansion," for the purpose of expanding the Red Bike program to include Bond Hill, Roselawn, Evanston, and Avondale to provide for fitness, transportation, and healthy living; **AUTHORIZING** the transfer of \$500,000 from the General Fund balance sheet reserve account no. 050x2580, "Reserve for Weather Related Events, Other Emergency and One-Time Needs," to the unappropriated surplus of General Fund 050; **AUTHORIZING** the transfer and appropriation of \$500,000 from the unappropriated surplus of General Fund 050 to newly established capital improvement program project account no. 980x233x222390, "Red Bike Program Expansion," for the purpose of expanding the Red Bike program to include Bond Hill, Roselawn, Evanston, and Avondale to provide for fitness, transportation, and healthy living; and **DECLARING** expenditures from capital improvement program project account no. 980x233x222390, "Red Bike Program Expansion," to be for a public purpose.

WHEREAS, Council wishes to provide for fitness, transportation, and healthy living in the Bond Hill, Roselawn, Evanston, and Avondale neighborhoods; and

WHEREAS, an expansion of the Red Bike program would help accomplish those goals in the aforementioned neighborhoods; and

WHEREAS, the source of funds is the "Reserve for Weather Related Events, Other Emergency and One-Time Needs"; now, therefore,

BE IT ORDAINED by the Council of the City of Cincinnati, State of Ohio:

Section 1. That the new capital improvement program project account no. 980x233x222390, "Red Bike Program Expansion," is hereby established for the purpose of expanding the Red Bike program to include Bond Hill, Roselawn, Evanston, and Avondale to provide for fitness, transportation, and healthy living.

Section 2. That the sum of \$500,000 is hereby transferred from the General Fund balance sheet reserve account no. 050x2580, "Reserve for Weather Related Events, Other Emergency and One-Time Needs," to the unappropriated surplus of General Fund 050.


Section 3. That the sum of \$500,000 is hereby transferred and appropriated from the unappropriated surplus of General Fund 050 to newly established capital improvement program project account no. 980x233x222390, "Red Bike Program Expansion," for the purpose of expanding the Red Bike program to include Bond Hill, Roselawn, Evanston, and Avondale to provide for fitness, transportation, and healthy living.


Section 4. That Council hereby declares that expenditures from capital improvement program project account no. 980x233x222390, "Red Bike Program Expansion," will serve a public purpose because the project will provide for fitness, transportation, and healthy living for citizens in the City of Cincinnati.


Section 5. That the proper City officials are authorized to do all things necessary and proper to carry out the terms of Sections 1 through 4 hereof.

Section 6. That this ordinance shall be an emergency measure necessary for the preservation of the public peace, health, safety, and general welfare and shall, subject to the terms of Article II, Section 6 of the Charter, be effective immediately. The reason for the emergency is the immediate need to ensure funds are provided for the Red Bike program expansion.
