WHEREAS, at age 16 while still in high school, Ms. Dillingham began working in group homes serving individuals with severe mental illness, and later began her career at Mental Health Access Point, before moving to the Central Clinic as a case manager in the Adult Services Division; and

WHEREAS, Ms. Dillingham has advocated for many years on behalf of Cincinnati families struggling with homelessness, addiction, food equity, and disabilities, particularly in her roles as project manager for a Temporary Assistance for Needy Families ("TANF") grant to the Freestore Foodbank and as project coordinator for Affordable Housing Advocates; and

WHEREAS, Ms. Dillingham has mentored many students of social work and since 2011 has served as a field instructor and adjunct professor of graduate and undergraduate students at the University of Cincinnati School of Social Work, while also working with students from The Ohio State University, Miami University, University of Southern California, University of Kentucky, and Xavier University; and

WHEREAS, as CEO of Community Shares of Greater Cincinnati, an organization supporting area non-profits, Ms. Dillingham built coalitions and initiatives to tackle some of the toughest issues facing Cincinnati, including youth gun violence, food insecurity, and affordable housing; and

WHEREAS, Ms. Dillingham has worked as a union organizer with the Cincinnati Federation of Teachers, as the Director of Education for the Greater Cincinnati Coalition for the Homeless, and as coordinator for the Cincinnati Educational Justice Coalition, serving the children of our city and advocating for improving the working and living conditions of Cincinnati's families; now, therefore,
