

## **Accepted Non-Hazardous Waste:** Waste Items Not Accepted:

Yard Waste (including branches & leaves)

Furniture (wooden, metal, sofas, mattresses)

Electronic Waste & Household Trash

Metal & Construction Debris

Bricks, Concrete, & Asphalt

Tires (limited 10 per vehicle each event)

Chemicals & wet paint Oils & other hazardous waste Refrigerant/CFC-containing items (air conditioner, refrigerator) Compressed gas canisters

## **Restrictions:**

**ONLY City of Cincinnati Residents** proof of residency required

### **Vehicle Limitations**

NO trailers over 8 ft., double axel trailers, box trucks 15 ft. or larger, or dump trucks
