AUTHORIZING the City Manager to accept a monetary donation of \$2,585 from Indigo Sports to support the Cincinnati Recreation Commission's Christmas activities for youth; **AUTHORIZING** the City Manager to accept an in-kind donation of assorted gifts collected by the Cincinnati Recreation Department's annual toy drive at its golf facilities to support the Cincinnati Recreation Commission's Christmas activities for youth; and **AUTHORIZING** the Finance Director to deposit the monetary donation from Indigo Sports into Fund 319, "Contributions for Recreation Purposes."

WHEREAS, Indigo Sports intends to make a monetary donation in the amount of \$2,585 to the Cincinnati Recreation Commission ("CRC") for Christmas activities for youth in underprivileged communities; and

WHEREAS, assorted gifts were collected by the Cincinnati Recreation Department's annual toy drive at its golf facilities, which will be donated to CRC for Christmas activities for youth in underprivileged communities; and

WHEREAS, acceptance of the donations requires no matching funds, and there are no FTEs associated with the donations; and

WHEREAS, these donations are in accordance with the "Collaborate" goal to "[u]nite our communities" as described on pages 210-211 of Plan Cincinnati (2012); now, therefore,

BE IT ORDAINED by the Council of the City of Cincinnati, State of Ohio:

Section 1. That the City Manager is hereby authorized to accept a monetary donation of \$2,585 from Indigo Sports to support the Cincinnati Recreation Commission's Christmas activities for youth.

Section 2. That the City Manager is hereby authorized to accept an in-kind donation of assorted gifts collected by the Cincinnati Recreation Department's annual toy drive at its golf facilities to support Cincinnati Recreation Commission's Christmas activities for youth.


Section 3. That the Finance Director is hereby authorized to deposit the monetary donation of \$2,585 from Indigo Sports into Fund 319, "Contributions for Recreation Purposes."


Section 4. That the proper City officials are hereby authorized to do all things necessary and proper to carry out the provisions of Sections 1 through 3 herein.


Section 5. That this ordinance shall be an emergency measure necessary for the preservation of the public peace, health, safety, and general welfare and shall, subject to the terms of Article II, Section 6 of the Charter, be effective immediately. The reason for the emergency is the immediate need to accept the donations in support of the Cincinnati Recreation Commission's Christmas activities for youth.
