

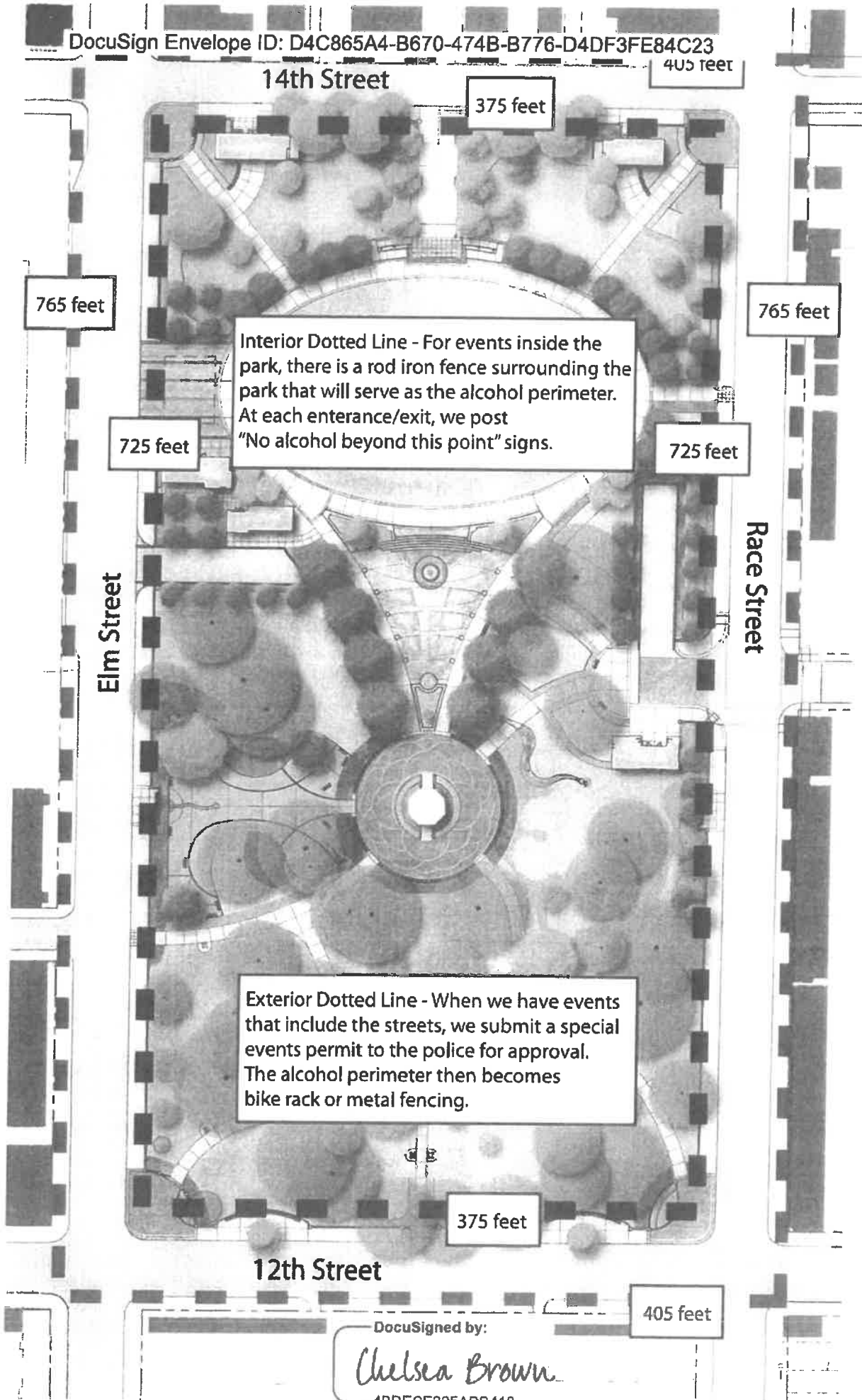

Exterior Dotted Line - When we have events that include the streets, we submit a special events permit to the police for approval. The alcohol perimeter then becomes bike rack or metal fencing.
