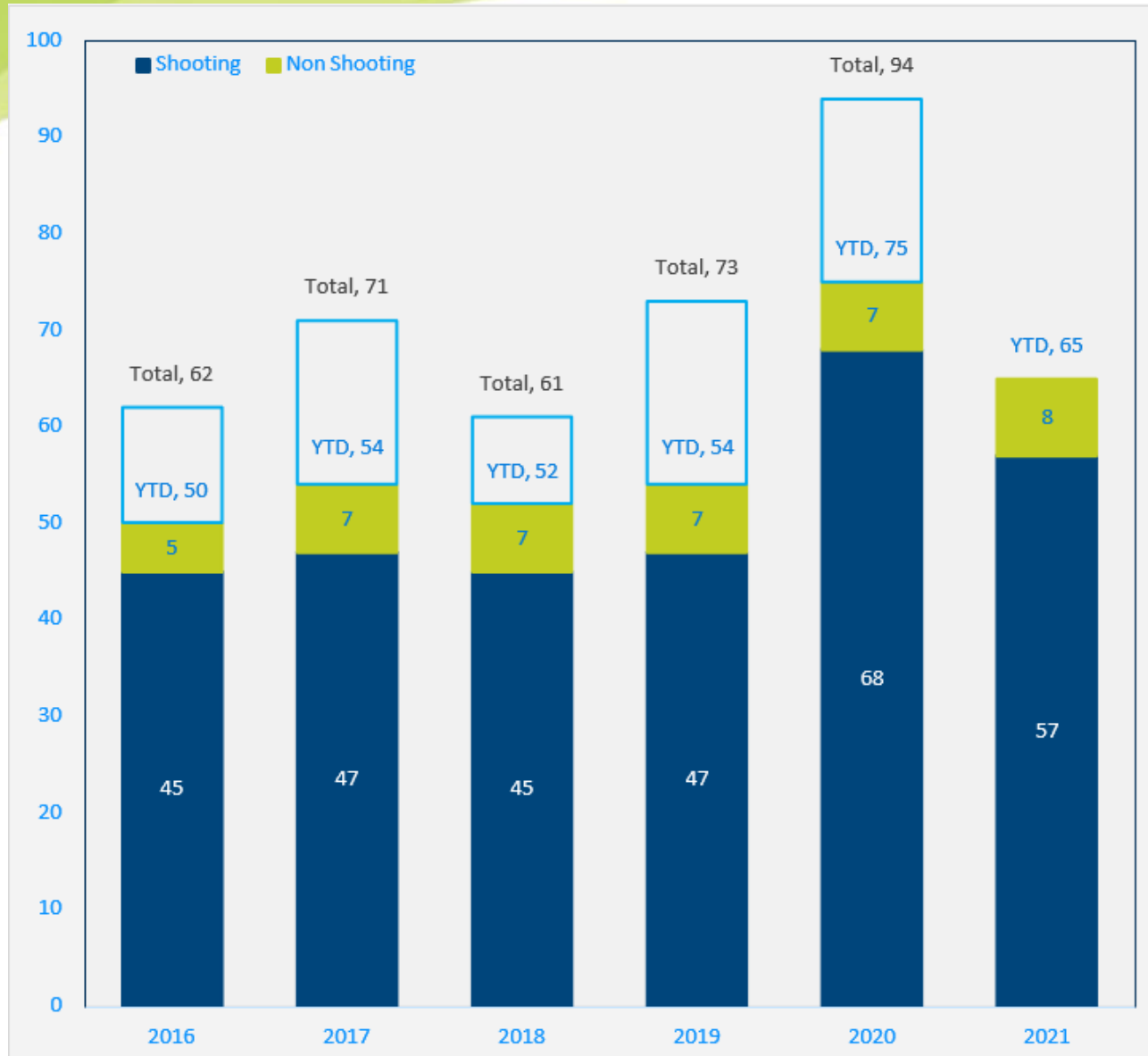




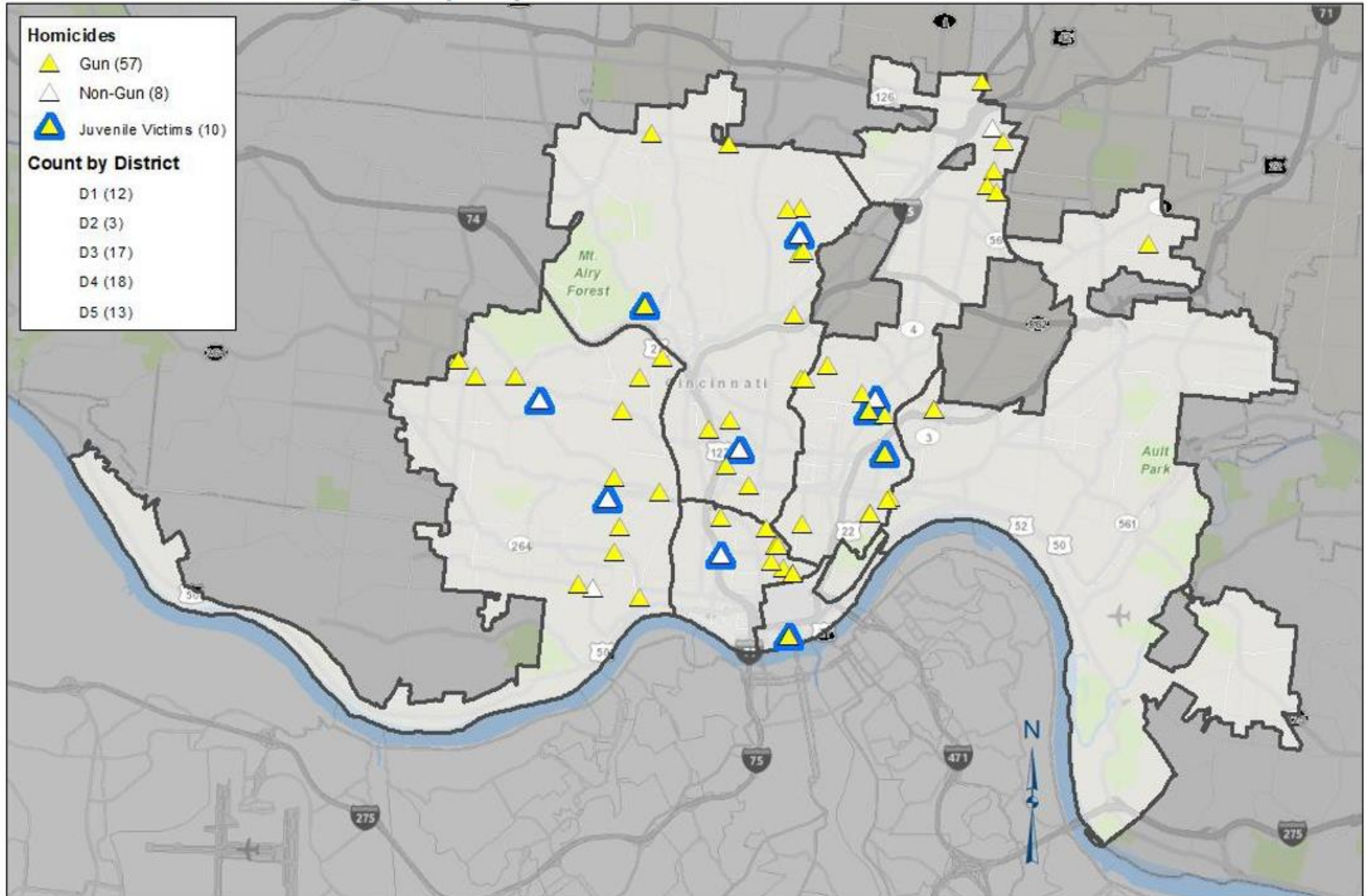

# Year To Date Gun and non-Gun Homicides



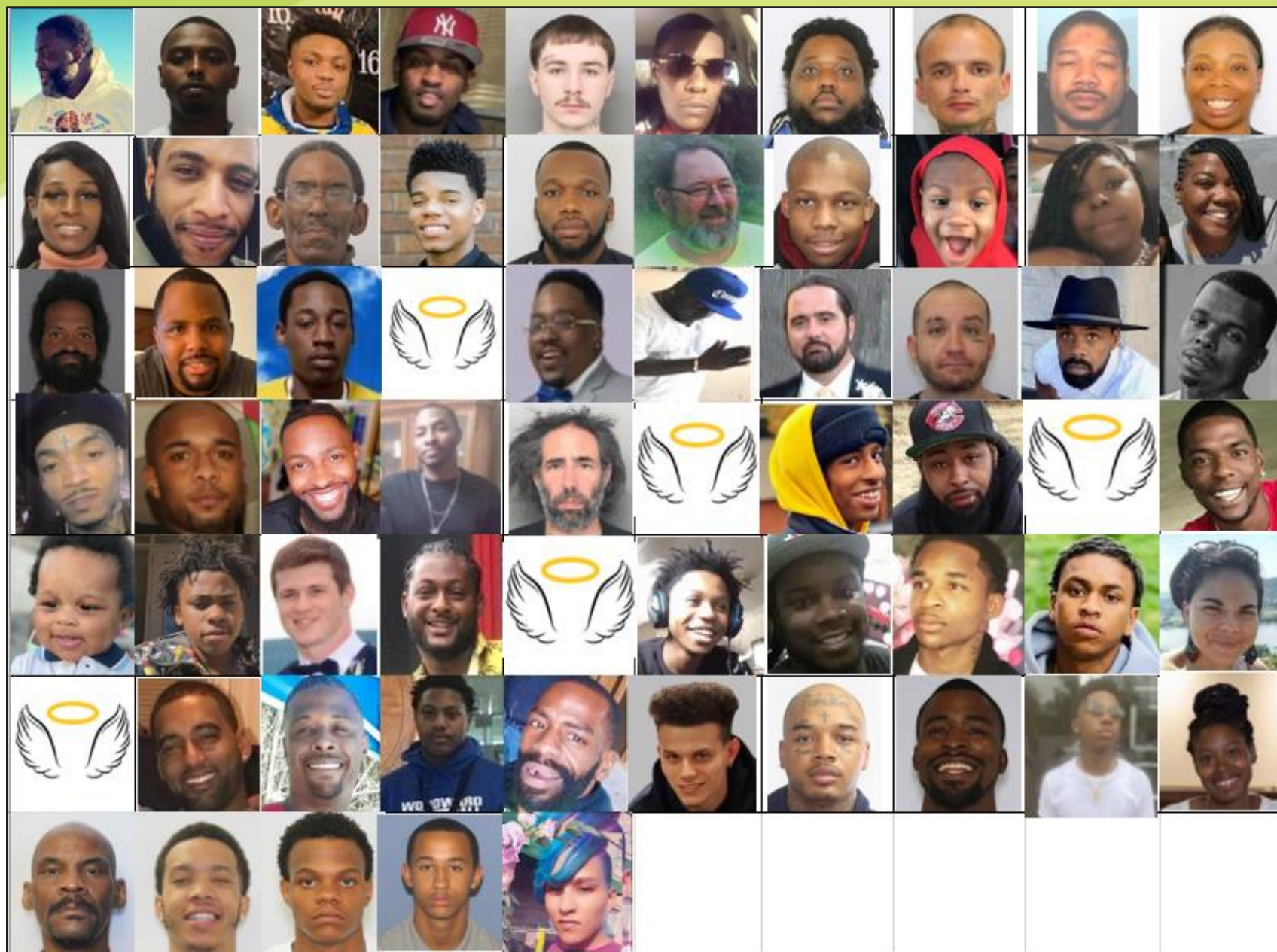
# Homicide Victims across Cincinnati: Year-to-Date through 09/27/2021



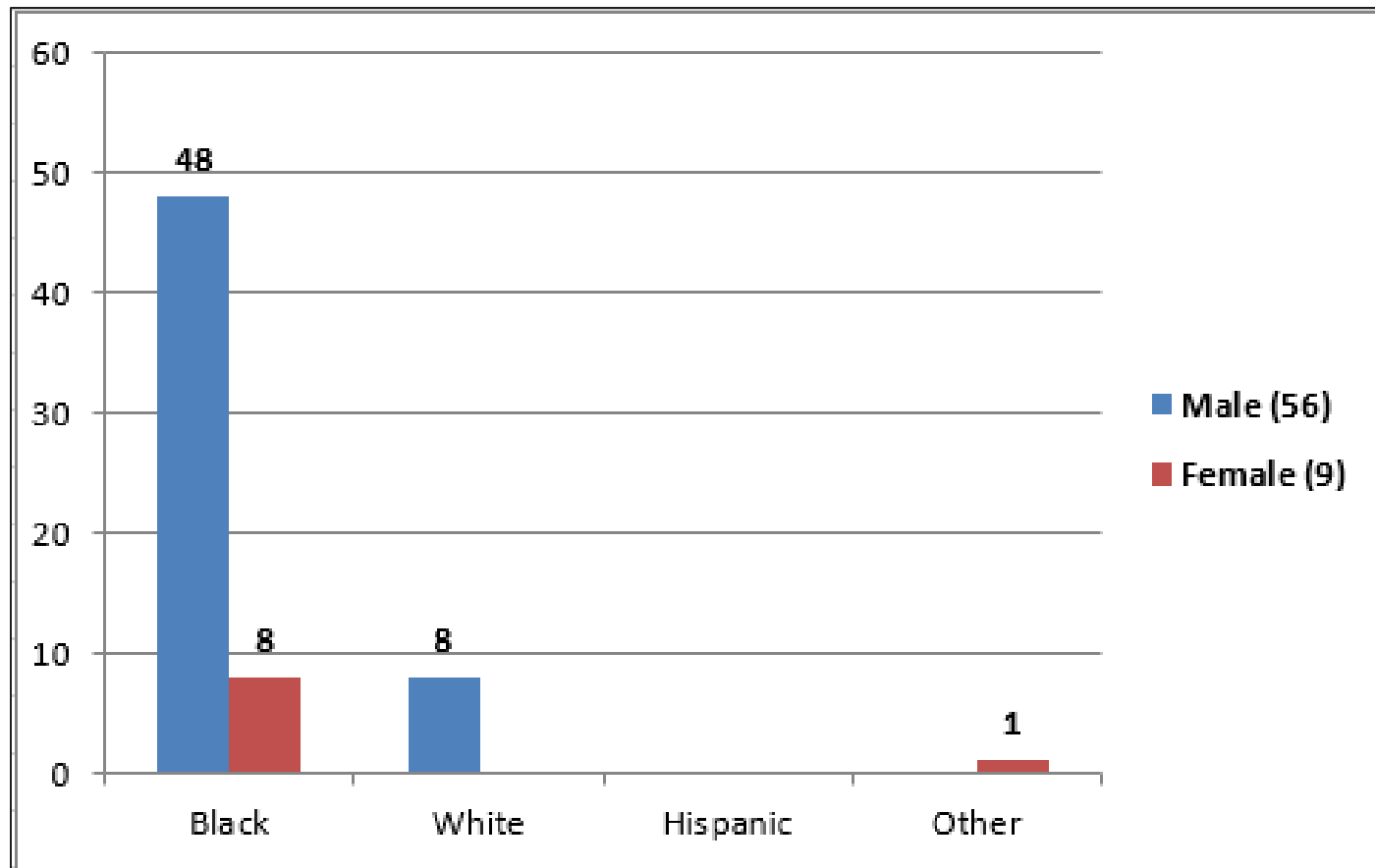

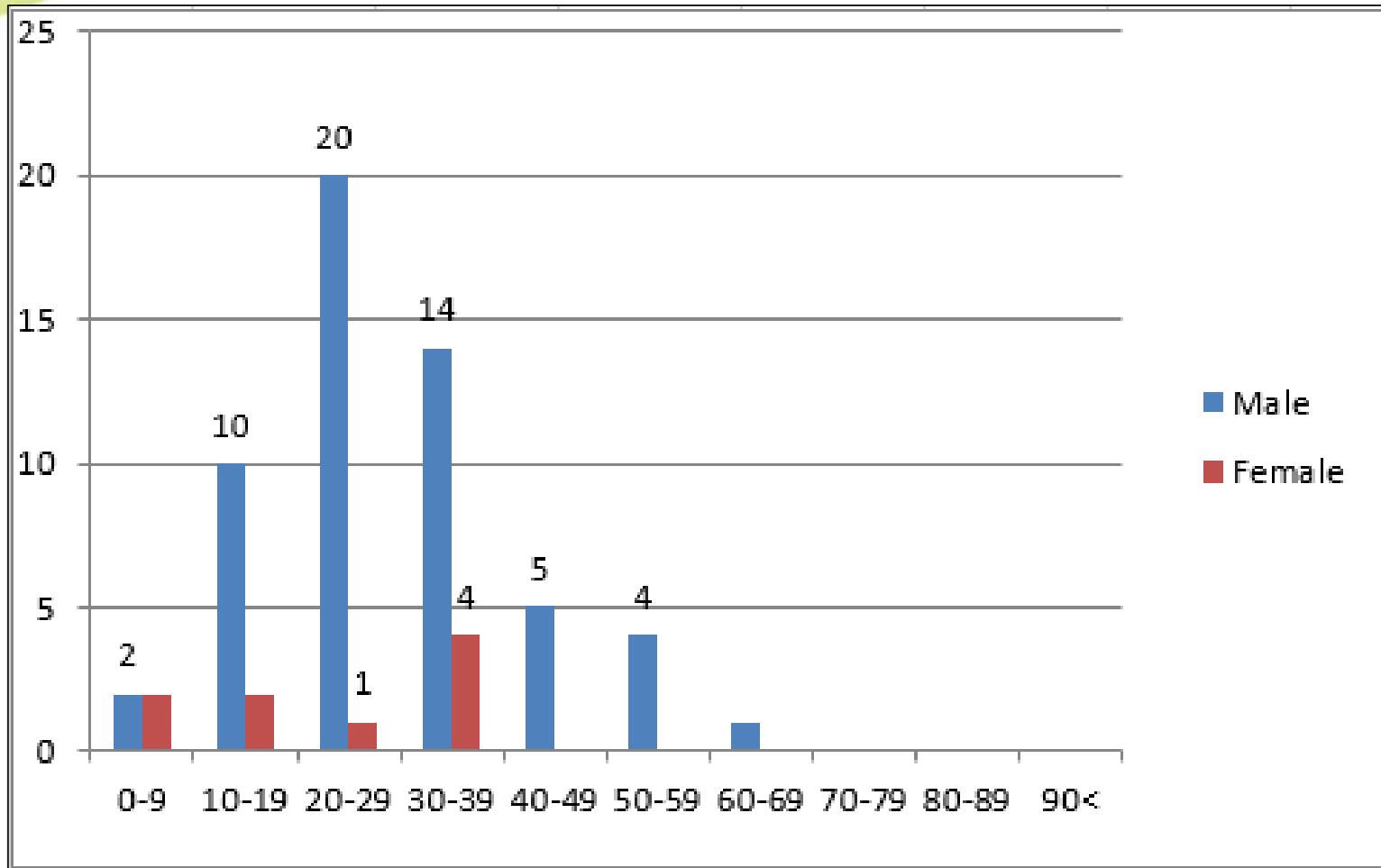

# Case Closure Rate

- 2021 Closure Rate is 68% (2020 – 69%)
- A positive closure is considered:
  - Arrest
  - Death of Offender
  - Prosecution Declined
  - Suspect awaiting Grand Jury Presentation

- Adult victims – 55/ Juvenile victims – 10

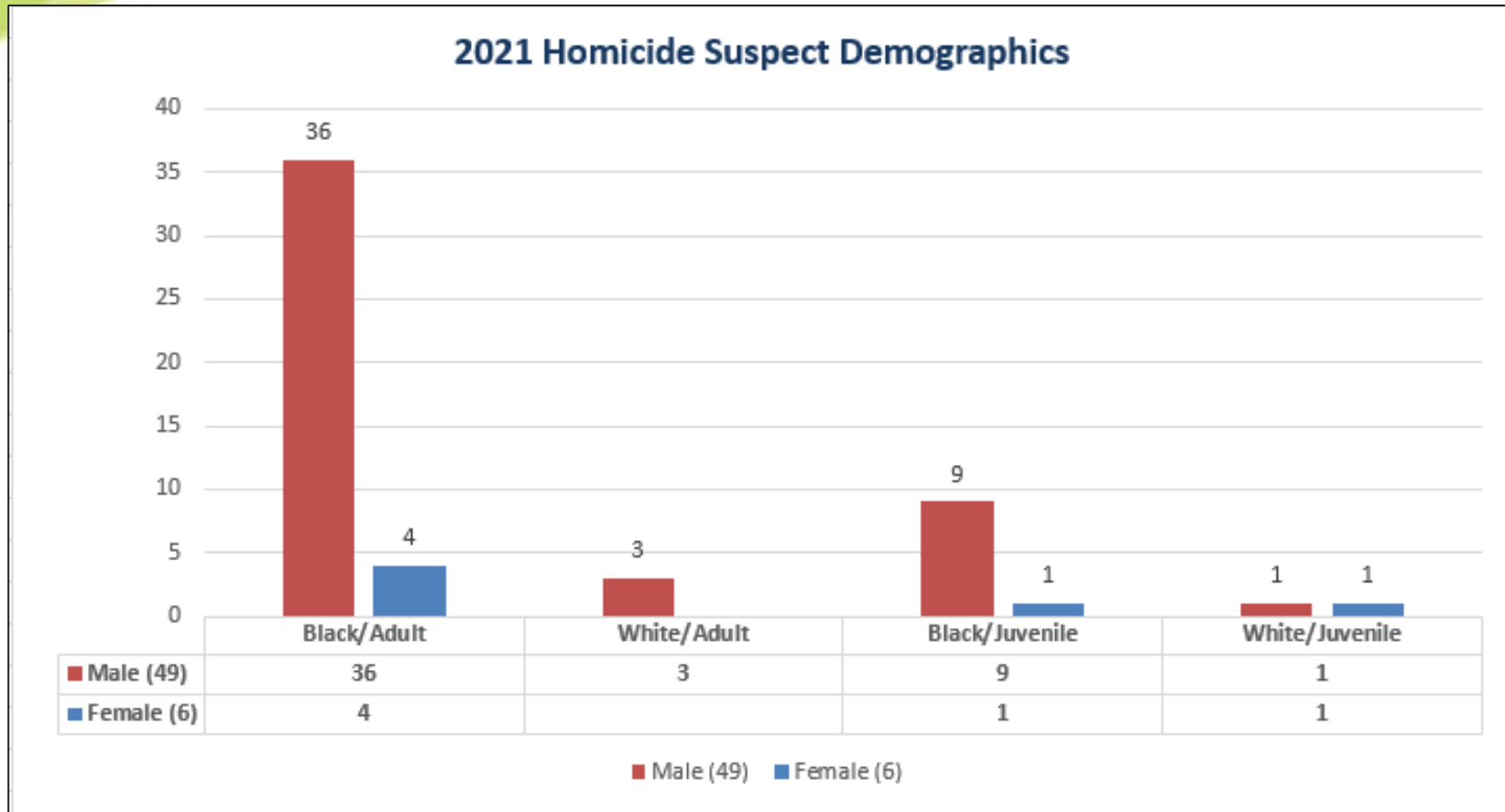
