Roselawn does not need any more liquor establishments in our neighborhood and we do not need all night bars operating under the guise of a restaurant. Brandy's Lounge, which has been a magnet for murders, is just a few doors away on Reading Road. There have already been more than enough shootings and deaths at nightclubs in Roselawn. Having a bar that close to our homes is unsafe. In addition to this history of problems, there is a bar being operated at 7759 Reading Rd, without a liquor license and this nightclub plague is intensifying.

As a community, we have fought long and hard to make Roselawn a better place for all residents. Establishments like the one that Brenda Harvey, and the people that are leasing from her, is proposing is like a plague to our neighborhood. The residents that live in direct proximity to this proposed club were not notified of plans to open this establishment. We are appalled that people who live outside of our neighborhood want to put establishments in Roselawn that are detrimental to community growth and development.
