Attached is an Emergency Ordinance captioned:

**AUTHORIZING** the City Manager to accept and appropriate additional Surface Transportation Block Grant ("STBG") (ALN 20.205) resources awarded from an existing Ohio-Kentucky-Indiana ("OKI") Regional Council of Governments grant in an amount up to \$1,199,998 to existing capital improvement program project account no. 980x232x222355, "Wasson Way Federal STBG 2022," for the purpose of providing additional resources to complete the Wasson Way Phase 6A project (PID 112894); and AUTHORIZING the City Manager to execute any agreements necessary for the receipt and administration of these grant awards.

This Emergency Ordinance authorizes the City Manager to accept and appropriate additional Surface Transportation Block Grant (STBG) (ALN 20.205) resources from an existing Ohio-Kentucky-Indiana (OKI) Regional Council of Governments grant in an amount up to \$1,199,998 to existing capital improvement program project account no. 980x232x222355, "Wasson Way Federal STBG 2022," for the purpose of providing additional resources to complete the Wasson Way Phase 6A project (PID 112894). This Emergency Ordinance also authorizes the City Manager to execute any agreements necessary for the receipt and administration of these grant awards.

Due to increased estimated constructions costs associated with the Wasson Way Phase 6A project, the Department of Transportation and Engineering (DOTE) must redistribute existing capital grant resources allocated for Wasson Way Phases 3, 4, and 5 and accept an administrative increase to a previously approved grant award.

The STBG grant requires matching resources of up to \$955,864, which will be provided from existing Wasson Way capital improvement program project account nos. 980x232x212371, 980x232x222371, and 980x232x232371, as well as Bicycle Transportation Program capital improvement program project account no. 980x232x222357. No new FTEs are associated with this grant.

The Wasson Way Trail project is in accordance with the "Connect" goal to "[d]evelop an efficient multi-modal transportation system that supports neighborhood livability" as well as with strategies to "[e]xpand options for non-automotive travel" and to "[p]lan, design, and implement a safe and sustainable transportation system," as described on pages 129-138 of Plan Cincinnati (2012).

The reason for the emergency is the immediate need to provide resources to complete the Wasson Way Phase 6A project.

The Administration recommends passage of this Emergency Ordinance.

WHEREAS, due to increased estimated construction costs associated with the Wasson Way Phase 6A project, the Department of Transportation and Engineering must redistribute existing capital grant resources allocated for Wasson Way Phases 3, 4, and 5 and accept an administrative increase in a previously approved grant award; and

WHEREAS, Ordinance No. 0165-2019 authorized the City Manager to apply for STBG resources in an amount up to \$6,000,000; and

WHEREAS, Ordinance No. 0025-2022 authorized the City Manager to accept and appropriate up to \$1,667,595 from the Surface Transportation Block Grant ("STBG") to capital improvement program project account no. 980x232x222355, "Wasson Way Federal STBG 2022"; and

WHEREAS, the STBG grant requires matching resources of up to \$955,864, which will be provided from existing Wasson Way capital improvement program project account nos. 980x232x212371, 980x232x222371, and 980x232x232371, as well as Bicycle Transportation Program capital improvement program project account no. 980x232x222357; and

WHEREAS, no new FTEs are required to accept this grant; and

WHEREAS, these grant funds will not be deposited into City accounts, as the Grantor is paying the City vendor performing the services directly; and

WHEREAS, the Wasson Way Trail project is in accordance with the "Connect" goal to "[d]evelop an efficient multi-modal transportation system that supports neighborhood livability," as well as the strategies to "[e]xpand options for non-automotive travel" and to "[p]lan, design, and implement a safe and sustainable transportation system," as described on pages 129-138 of Plan Cincinnati (2012); now, therefore,

BE IT ORDAINED by the Council of the City of Cincinnati, State of Ohio:

Section 1. That the City Manager is hereby authorized to accept and appropriate additional Surface Transportation Block Grant ("STBG") (ALN 20.205) resources awarded from an existing Ohio-Kentucky-Indiana ("OKI") Regional Council of Governments grant in an amount up to \$1,199,998 to existing capital improvement program project account no. 980x232x222355, "Wasson Way Federal STBG 2022," for the purpose of providing additional resources to complete the Wasson Way Phase 6A project (PID 112894).

WHEREAS, the annual Girls in Government Day event is in accordance with the Plan Cincinnati "Live" goal to "[b]uild a robust public life," and the strategies to "[d]evelop and maintain inviting and engaging public spaces to encourage social interaction between different types of people," and "[c]reate a welcoming civic atmosphere," as described on pages 147-155 of Plan Cincinnati (2012); now, therefore,

This Emergency Ordinance authorizes the transfer of \$25,000 from the balance sheet reserve account 050x2535, "Reserve for Operating Budget Contingencies," to the unappropriated surplus of the General Fund 050. This Emergency Ordinance further authorizes the transfer of the sum of \$25,000 from the unappropriated surplus of the General Fund 050 to the City Manager's Office General Fund non-personnel operating budget account no. 050x101x7400 for the purpose of providing one-time funds for additional Safe and Clean projects.

Existing funds for Safe and Clean projects have been exhausted through previous rounds of funding, however, there are additional projects that can be funded in FY 2023 with an additional \$25,000. The City's Stabilization Funds Policy was revised per Ordinance No. 0056-2022 to create a "Reserve for Operating Budget Contingencies" balance sheet reserve account to be utilized for one-time budget needs that occur during the fiscal year. Sufficient funds exist in the "Reserve for Operating Budget Contingencies" balance sheet reserve account to provide the one-time funds needed for additional Safe and Clean projects.

The reason for the emergency is the immediate need to make funding available for additional Safe and Clean projects.

The Administration recommends passage of this Emergency Ordinance.

The development of a detailed facilities master plan, which will identify and prioritize Cincinnati Health Department properties and repairs is in accordance with the "Sustain" goal to "[m]anage our financial resources," and strategy to "[s]pend public funds more strategically," as described on pages 199-205 of Plan Cincinnati (2012).

The reason for the emergency is the immediate need to begin working on a master facilities plan before the end of FY 2023.

The Administration recommends passage of this Emergency Ordinance.
