DECLARING that Gilbert Avenue at Florence Avenue in the Walnut Hills neighborhood shall hereby receive the honorary, secondary name of David L. Cole Memorial Way, in memory of Cincinnati Police Officer David L. Cole and in recognition of his service to the City of Cincinnati.

WHEREAS, Officer David L. Cole served the Cincinnati Police Department from July 20, 1969 to July 17, 1974; and

WHEREAS, Officer Cole was born on December 30, 1949, in Cincinnati, to Police Officer James E. and Ruth Cole and was the eldest sibling to Kenny, James, Connie, and Steve; and

WHEREAS, Officer Cole graduated from Amelia High School in 1969 and was the co-captain of the wrestling team; and

WHEREAS, on July 20, 1969, Officer Cole joined the Cincinnati Police Division as a Police Cadet; and

WHEREAS, on August 12, 1972, Officer Cole married his high school sweetheart, Cheryl Haas, at St. Bernadette Church in Amelia; and

WHEREAS, Officer Cole served at Police Communications and in District 6 while attending the University of Cincinnati, where he graduated with an Associate Degree in Police Science, and on October 29, 1972, Officer Cole was promoted to Police Recruit, and on February 25, 1973, he was promoted to Patrolman, issued Badge No. 160, and reassigned to District 6; and

WHEREAS, in 1973, Officer Cole joined the Ohio National Guard and on March 31, 1974, he was rotated to District 7; and

WHEREAS, in 1974, Officer Cole and his wife purchased a new home, and he was getting ready to study for the next promotional examination for Police Sergeant; and

WHEREAS, on July 16, 1974, Officer Cole changed his off day to attend a weekend drill with the National Guard; and

WHEREAS, on July 17, 1974, Officer David L. Cole lost his life at 24 years of age in the line of duty; and

WHEREAS, Officer David L. Cole was dedicated to his job and devoted to his family and an exemplary officer and a fun-loving person; and

WHEREAS, Officer Cole served his community and country for almost 5 years, and was a City employee for almost 5 years, a husband almost 2 years, a Patrolman for 1 ½ years, and served in the Ohio National Guard for 1 year; and

WHEREAS, the City of Cincinnati seeks to remember those who have given their lives in the line of duty and so they will never be forgotten; now, therefore,

BE IT ORDAINED by the Council of the City of Cincinnati, State of Ohio:

Section 1. That Gilbert Avenue at Florence Avenue in the Walnut Hills neighborhood shall hereby receive the honorary, secondary name of David L. Cole Memorial Way in honor of Cincinnati Police Officer David L. Cole and in recognition of his service to the City of Cincinnati.

Section 2. That the appropriate City officials are hereby authorized to do all things necessary and proper to implement the provisions of Section 1 herein, including the generation and installation of appropriate secondary street signage, which shall designate Gilbert Avenue at Florence Avenue in the Walnut Hills neighborhood as David L. Cole Memorial Way in accordance with the Department of Transportation and Engineering's procedures relating to street designation and related signage.

Section 3. That the Clerk of Council shall cause a copy of this ordinance to be provided to the family of Cincinnati Police Officer David L. Cole via the office of Councilmember Christopher Smitherman.

DECLARING that Vine Street at McMillan Street in the Mount Auburn neighborhood shall hereby receive the honorary, secondary name of Pope-Jeter Memorial Way, in memory of Cincinnati Police Officer Daniel J. Pope and Police Specialist Ronald D. Jeter and in recognition of their service to the City of Cincinnati.

WHEREAS, Police Office Daniel J. Pope served the Cincinnati Police Department from September 1991 to December 1997 and Police Specialist Ronald D. Jeter served from February 1993 to December 1997; and

WHEREAS, Officer Pope was born on January 8, 1962, to Cincinnati Police Officer Robert L. and Mary Jane Pope and attended North College Hill High School graduating in June 1980; and

WHEREAS, on December 11, 1990, Officer Pope married Linda L. Meyer, who was a Cincinnati Fire Fighter, and on September 15, 1991, Officer Pope joined the Cincinnati Police Division as a Police Recruit; and

WHEREAS, on February 2, 1992, Officer Pope was promoted to Police Officer, issued Badge No. 256, and assigned to District 3; and

WHEREAS, on November 14, 1993, Officer Pope rotated to District 4, and a year and a half later, he transferred to District 5, where, according to his supervisor, he was becoming a relief leader and was sought out by others for advice and assistance; and

WHEREAS, in November 1995, District Commander Captain Phyllis A. Caskey wrote Officer Pope a District-Level commendation for the capture of two armed robbers; and

WHEREAS, in 1996, Officer Pope was assigned to the District 5 Criminal Apprehension Team (CAT) where his sergeant assessed him as an "aggressive officer who seems to be working well" with his partner, Specialist Ronald Jeter; and

WHEREAS, Specialist Ronald D. Jeter was born in 1963 to his mother Brenda Collier and was brother to Terry Slocum and Robert Slocum and cousin to Police Officer Deon Cromwell; and

WHEREAS, Specialist Jeter's children are Kayla Curry-Jeter, Brandon Jeter, and Brittany Jeter; and

WHEREAS, Specialist Jeter graduated from Beechcroft High School in Columbus, Ohio in 1982 and thereafter enlisted in the United States Marine Corps Reserve where he served on active duty until April 1983; and

WHEREAS, Specialist Jeter attended Columbus State College from 1983 to 1988, majoring in finance, and from 1986 to 1993 he worked for Nationwide Insurance, United Insurance in Columbus, and American Loyalty; and

WHEREAS, on February 7, 1993, Specialist Jeter joined the Cincinnati Police Department as a Police Recruit, and on June 27, 1993, he was promoted to Police Officer and issued Badge Number 375 and assigned to District 1; and

WHEREAS, in 1994 Specialist Jeter rotated to District 5 and in 1995, he was assigned to the District 5 Criminal Apprehension Team (CAT), and further in 1996, Specialist Jeter was additionally assigned to the Special Weapons and Tactics (SWAT) Team; and

WHEREAS, on January 26, 1997, Specialist Jeter was promoted to Police Specialist and issued Badge No. PS121; and

WHEREAS, by December 1997, with only 4¾ years' experience, Specialist Jeter had received 10 letters of appreciation and/or commendation, including four from Police Chief Michael Snowden and two from Patrol Bureau commanders; and

WHEREAS, Officer Pope and Specialist Jeter were exemplary police officers with bright futures ahead of them in the Cincinnati Police Department and in the City of Cincinnati; and

WHEREAS, on the evening of December 6th, 1997, Officer Pope and Specialist Jeter lost their lives in the line of duty while attempting to arrest a suspect on an outstanding domestic violence warrant; and

WHEREAS, the City of Cincinnati seeks to remember those who have given their lives in the line of duty and so they will never be forgotten; now, therefore,

BE IT ORDAINED by the Council of the City of Cincinnati, State of Ohio:

Section 1. That Vine Street at McMillan Street in the Mount Auburn neighborhood shall hereby receive the honorary, secondary name of Pope-Jeter Memorial Way in honor of Cincinnati Police Officer Daniel J. Pope and Police Specialist Ronald D. Jeter and in recognition of their service to the City of Cincinnati.

Section 2. That the appropriate City officials are hereby authorized to do all things necessary and proper to implement the provisions of Section 1 herein, including the generation and installation of appropriate secondary street signage, which shall designate Vine Street at McMillan Street in the Mount Auburn neighborhood as Pope-Jeter Memorial Way in accordance

with the Department of Transportation and Engineering's procedures relating to street designation and related signage.

DECLARING that Rockdale Avenue shall hereby receive the honorary, secondary name of Alvertis W. Bishop Way, in memory of Alvertis W. Bishop, recognizing his contributions as a businessman to the City of Cincinnati and as a vital member of the Avondale community.

WHEREAS, Alvertis W. Bishop was born in 1914 to parents Walter and Helen Bishop; and

WHEREAS, Mr. Bishop graduated high school at age 16, and obtained a bachelor's degree from Bluefield State Teachers College in West Virginia; and

WHEREAS, Mr. Bishop then moved to Cincinnati, first working as a Pullman Porter and later as a machinist's assistant and as one of the first Black foremen at the Wright Aeronautical Plant in Evendale (now known as General Electric Company); and

WHEREAS, Mr. Bishop helped produce several of the Wright Cyclone engines used in American aircraft that contributed to the Allies' victory in World War II; and

WHEREAS, in 1957, Mr. Bishop opened a service station in Avondale at Rockdale and Burnet Avenues, using the knowledge of auto mechanics acquired from his father; and

WHEREAS, Mr. Bishop was deeply rooted in the Avondale community, serving as the president of the Burnet Area Business and Professional Men's Association, as well as a devoted member of Carmel Presbyterian Church; and

WHEREAS, through his membership as a Prince Hall Freemason, 32nd Degree, and as a Shriner, Sinai Temple No. 59, Mr. Bishop worked to better the lives of all Cincinnatians; and

WHEREAS, in 1989 Mr. Bishop passed away at age 74; now, therefore,

BE IT ORDAINED by the Council of the City of Cincinnati, State of Ohio:

Section 1. That Rockdale Avenue at Burnet Avenue shall hereby receive the honorary, secondary name of "Alvertis W. Bishop Way" by legislative action of the Mayor and City Council in honor of Alvertis W. Bishop, recognizing his contributions as a businessman to the City of Cincinnati and as a vital member of the Avondale community.

Section 2. That the appropriate City officials are hereby authorized to do all things necessary and proper to implement the provisions of Section 1 herein, including the generation and installation of appropriate secondary street signage, which shall designate Rockdale Avenue at Burnet Avenue as “Alvertis W. Bishop Way,” in accordance with the Department of Transportation and Engineering’s procedures relating to secondary street designation.

DECLARING that Allston Street shall hereby receive the honorary, secondary name of James T. Aglamesis Way, in memory of James T. Aglamesis and in recognition of his contributions to the City of Cincinnati through entrepreneurship.

WHEREAS, James T. Aglamesis was the oldest son of Thomas and Viola Aglamesis; and

WHEREAS, Mr. Aglamesis, a Cincinnati native, graduated from the University of Cincinnati in 1950; and

WHEREAS, Mr. Aglamesis assumed leadership of Aglamesis Brothers during the 1950s following his father’s declining health; and

WHEREAS, Aglamesis Brothers, co-founded in 1908 by brothers Thomas and Nicholas Aglamesis, specializes in ice cream and candy manufacturing; and

WHEREAS, Mr. Aglamesis advanced the business through expansion and modernization, opening a second location in the Montgomery Square Shopping Center in 1970 and remodeling the Oakley location to include a new storefront and a small chocolate production area, for which the company received the City of Cincinnati Beautification Award in 1965; and

WHEREAS, in 2016 Mr. Aglamesis transferred company leadership to his son Randy Young, but continued to work actively past age 90 in the company; and

WHEREAS, Mr. Aglamesis’ legacy lives on, as the company’s traditions continue under the leadership of the third and fourth generations of family members; now, therefore,

BE IT ORDAINED by the Council of the City Cincinnati, State of Ohio:

Section 1. That Allston Street shall hereby receive the honorary, secondary name of James T. Aglamesis Way by legislative action of the Mayor and City Council, in memory of James T. Aglamesis and in recognition of his contributions to the City of Cincinnati through entrepreneurship.

Section 2. That the appropriate City officials are hereby authorized to do all things necessary and proper to implement the provisions of Section 1 herein, including the generation
