

 - 7 community partners












Little Miami Trail Connector


The Mt. Washington

HISTORY of MWCC

Residents of Mt. Washington formed the Mt. Washington Community Council (MWCC) in 1925 to help represent the needs and interests of the community, which, at that time, felt like a long way, physically and otherwise, from governing bodies in downtown Cincinnati.

PURPOSE

MWCC, continues to empower Mt. Washington residents by representing the views and opinions of community members to the city's governing agencies, as well as, educating residents on any relevant policies and actions taken by city leaders. MWCC brokers the city's Neighborhood Support Program (NSP) grant annually, through an open vetting and voting process with membership. MWCC assists Mt. Washington residents, property and business owners in dealing with zoning, land use, traffic, safety, beautification, crime prevention, recreation and many other issues affecting our community.

MWCC organizes the Pumpkin Chuck, held the first Saturday after Halloween, every year.





Issues faced in MtW

Lack of sidewalks

Influx of Unhoused people not wanting services - fears of safety and inability of residents to enjoy public park and spaces, businesses losing business, trash piles up, used needles litter

Traffic - safety concerns: speeding and not stopping for pedestrians at crosswalks

Beechmont Avenue's poor condition: constantly gets potholes and is a patchwork

Theft - car theft and property theft from cars

Concern regarding distance from District 2 HQ

Unsightly medians going up the hill - many missing trees and constant weeds

Private roads that residents would like the city to takeover
