2. Project valuations shall be evaluated using applicants' estimated value of improvements and costs of construction published by the Engineering News-Record except as follows:
a. Retaining Walls: Portions of walls greater than 5' in height above grade shall be valued at \$391/lnft and portions of walls less than 5' in height above grade shall be valued at \$263/lnft.
