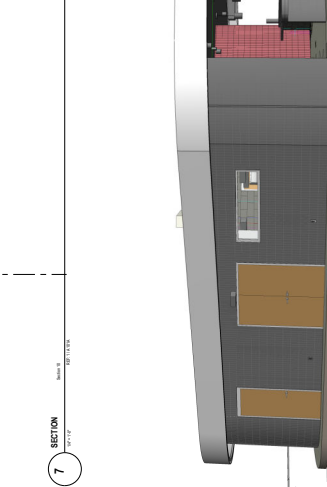
3D View 4



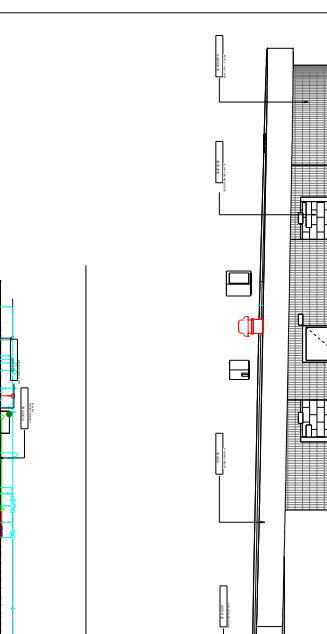
ELEVATION 3

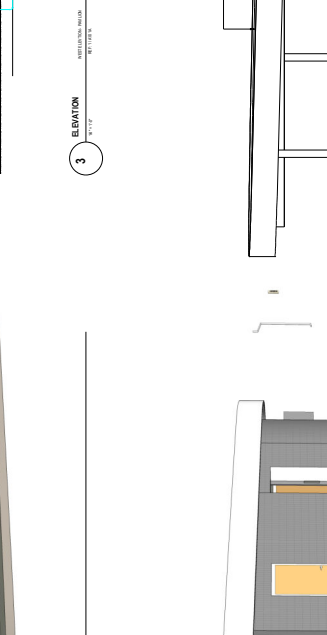
ELEVATION 2

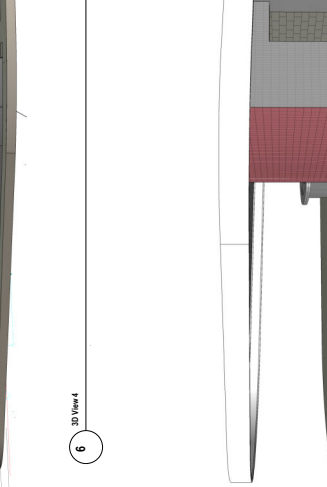
3D View 3

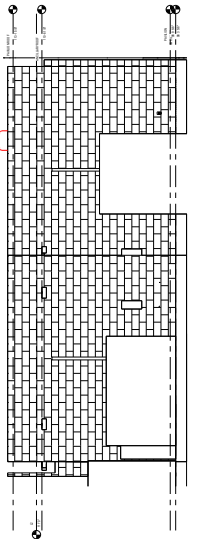
