An Ordinance No. 460

- 2025

AUTHORIZING the payment of \$65,501.69 from Enterprise Services Parking System Facilities Fund non-personnel operating budget account no. 102x248x2300x7289 to USquare, LLC for outstanding charges related to parking management services at the USquare @ The Loop parking garages for the period of July 1, 2025, to August 31, 2025, pursuant to the attached then and now certificate from the Director of Finance.

WHEREAS, on October 6, 2011, the City entered into a contract with USquare, LLC ("Contractor") to provide parking management services; and

WHEREAS, pursuant to the terms of the contract, Contractor provided parking management services from July 1, 2025, through August 31, 2025, totaling \$65,501.69, however the certification for funds for FY 2026 was not entered into the Cincinnati Financial System until September 26, 2025; and

WHEREAS, the Division of Parking has provided education on certification processes and has implemented procedures to ensure timely certifications in the future to prevent this problem from reoccurring; and

WHEREAS, pursuant to Ohio Revised Code Section 5705.41(D)(1), the Director of Finance has issued a certificate, attached to this ordinance, verifying that a sufficient sum was appropriated and in the City Treasury to pay such charges under the contract both at the time the contract began and at the time the attached certificate was issued; and

WHEREAS, Council desires to provide payment to Contractor for the City's outstanding obligation of \$65,501.69 for parking management services received from July 1, 2025, through August 31, 2025; now, therefore,

BE IT ORDAINED by the Council of the City of Cincinnati, State of Ohio:


Section 1. That the Director of Finance is authorized to pay \$65,501.69 from Enterprise Services Parking System Facilities Fund non-personnel operating budget account no. 102x248x2300x7289 to USquare, LLC for outstanding charges related to parking management services at the USquare @ The Loop parking garages for the period of July 1, 2025, to August 31, 2025.

Section 2. That the proper City officials are authorized to do all things necessary and proper to carry out the provisions of Section 1.

Section 3. That this ordinance shall be an emergency measure necessary for the preservation of the public peace, health, safety, and general welfare and shall, subject to the terms of Article II, Section 6 of the Charter, be effective immediately. The reason for the emergency is the immediate need to pay USquare, LLC for the outstanding charges in a timely manner.
