## What's under the umbrella of Human Services?



### Human Services Funding:

1. Manage partnership with United Way to subcontract with 74 projects+ the Impact Award.  
Includes partnership coordination with agencies that do the following work:
  - Youth Gun Violence Prevention & Reduction
  - Food Security (as it relates to gun violence)
  - Workforce Development
  - Housing Stability
2. Organize partner convenings.
3. Monitor benchmarks + metrics of projects, intervening when necessary.
4. Leadership of the Human Services Advisory Committee (HSAC) - monthly meetings.

### Access to Counsel

### Eviction Prevention ecosystem:

1. Management of contracts with 4 partners in the ecosystem: United Way, Legal Aid, the Hamilton County Clerk of Courts Help Center & HOME (Housing Opportunities Made Equal).
2. Management of the rent assistance disbursement strategies + spending review, and contract.
3. Oversight of the contract with Stout, the expert third party evaluator recently finishing Year 1 of study + operationalizing the second year of planning for a pre-filing intervention and a data dashboard.

## **What's under the umbrella of Human Services?**



### **Children's College Savings Account Pilot**

- 1. Manage the contract with UWGC: strategies, goals, milestones, partners, enrollment events.**
- 2. Explore potential to expand the pilot beyond year one.**



# Office of Human Services

## What's under the umbrella of Human Services?



### Safe & Clean Funding

1. Manage the contract with Keep Cincinnati Beautiful to include 3 funding cycles per year.
2. Review the funding recommendations from the Safe & Clean scoring committee.
3. Monitor the outcomes and spending of funded projects, intervening when necessary





## What's under the umbrella of Human Services?



### Trans Youth Mental Health & Safety

1. Manage the contract with Community Shares to include funding cycles in 2025 and 2026.
2. Monitor the outcomes and spending of funded projects, intervening when necessary.

## **What's under the umbrella of Human Services?**



### **Daytime One Stop Center Feasibility**

- 1. Working with others in City Administration & the community to explore the potential for a daytime one-stop center for people experiencing homelessness to receive help with basic needs and wraparound services.**

## **What's under the umbrella of Human Services?**



### **Constituent Advocacy and Referrals**

- 1. Work with constituents who call, email, and/or visit the City to request assistance with connections to housing services, food resources, mental health case management, etc.**
