Focus Areas

- Top ten pedestrian crash corridors – most crashes
- Schools/parks/community centers/ball fields – vulnerable people (children and elderly)
- Neighborhood Business
 Districts most people



FY2020 Improvements

- Restriping existing crosswalks
- Converting traditional crosswalks to zebra striping
- Stop signs
- Curb extensions
- Intersection re-design/narrowing

- Yield paddles in crosswalks
- Updated, brighter crosswalk signage
- Pedestrian countdown signals
- Rectangular rapid flashing beacons




FY2020 Pilot Projects

Several "firsts' in the City:

- Raised crosswalk
- Yield markings at mid-block crosswalks
- Reflective signpost blades
- Leading pedestrian intervals
- "Light Path" system at crosswalks
- Speed limit pavement markings in NBDs
- Blank out "No Right Turn on Red" signs

FY2021


Reached out to every community council to ask for priority lists.

- 170+ minor project requests
- 3 major safety projects (corridor traffic calming) are currently in design, but cannot move forward with construction until funding is available:
 - Linn Street: Court St to Central Parkway (West End)
 - Warsaw Ave: Grand Ave to Glenway Ave (East Price Hill)
 - Ludlow Ave: Central Parkway to Whitfield Ave (Clifton)



Why Linn St?

- More travel lanes than are necessary to carry existing traffic (7 lanes)
- High number of pedestrian crashes
- Complaints about speeding
- Complaints about motorists not yielding to pedestrians in crosswalks




Linn St Safety Improvements, \$7M

- Right-size the corridor to calm traffic from Court Street to Central Parkway
- Install pedestrian refuge islands
- Install curb extensions to narrow crosswalk distance
- Install pedestrian countdown signals
- Provide space for bicycles
- Provide full time parking on both sides of the street
- Without local funding the project will be on hold until at least 2025




Why Warsaw Ave?

- More travel lanes than are necessary to carry existing traffic
- High number of vehicle and pedestrian crashes
- Complaints about speeding
- Complaints about motorists not yielding to pedestrians in crosswalks




Warsaw Ave Safety Improvements, \$5M

- Right-size the corridor to calm traffic between Grand Ave and Glenway Ave
- Install pedestrian refuge islands
- Install curb extensions to narrow crosswalk distance
- Provide full time parking on one side of the street
- Without local funding the project will be on hold until at least 2025



Why Ludlow Ave?

- More travel lanes than are necessary to carry existing traffic
- Complaints about speeding
- Lack of safe crossings for pedestrians



Ludlow Ave Safety Improvements, \$7M

- Right-size the corridor from Whitfield Ave to Central Parkway to calm traffic
- Install pedestrian refuge islands
- Install curb extensions to narrow crosswalk distance
- Install new marked crosswalks
- Provide space for bicycles
- Provide full time parking on one side of the street
- Remove slip lanes
- Narrow intersections to slow turning cars
- Without local funding the project will be on hold until at least 2025
