**Objection to Liquor Permit Application** 

Special Investigations Section is in receipt of a liquor permit application from Madison Quickstop LLC, located at 6004 Madison Rd, Suite A, Cincinnati, OH 45227 (Permit #5411348). The permit applicant, Ibrahim Abudakar, has convictions for criminal damaging and disorderly conduct. The criminal damaging convictions stem from a long-term investigation from a prior establishment in the City of Cincinnati. Mr. Abudakar also has affiliations with current locations in the city of Cincinnati that have been problematic to the city. Both locations have received multiple radio runs that stem from criminal activity occurring on the property to nuisance calls from the surrounding neighborhoods. Special Investigations Section respectfully requests the city object to the issuance of a permit to this applicant.
