An Ordinance No. 345

- 2025

ESTABLISHING new capital improvement program project account no. 980x233x262326, "Purcell Walk PID 122990 Grant," to provide resources for pedestrian improvements in the East Price Hill neighborhood; **AUTHORIZING** the City Manager to apply for, accept, and appropriate a Transportation Alternatives grant (ALN 20.205) of up to \$480,000 awarded by the Ohio-Kentucky-Indiana Regional Council of Governments to the newly established capital improvement program project account no. 980x233x262326, "Purcell Walk PID 122990 Grant," to provide resources for pedestrian improvements in the East Price Hill neighborhood; **AUTHORIZING** the Director of Finance to deposit the grant resources into newly established capital improvement program project account no. 980x233x262326, "Purcell Walk PID 122990 Grant;" and **AUTHORIZING** the City Manager to do all things necessary to cooperate with the Director of the Ohio Department of Transportation to complete the pedestrian improvement project.

WHEREAS, a Transportation Alternatives ("TA") grant of up to \$480,000 is available from the Ohio-Kentucky-Indiana Regional Council of Governments for transportation projects; and

WHEREAS, the TA grant will be used to fund the Purcell Walk Improvements project, which includes the construction of 800 linear feet of sidewalk in the East Price Hill neighborhood with accompanying embankments, landscaping, and driveway construction; and

WHEREAS, the project will improve pedestrian access and safety in the vicinity of the library, pool, recreation center, and other community facilities; and

WHEREAS, local matching resources of up to \$120,000 are required for the grant, which will be available in future capital improvement program project accounts; and

WHEREAS, no new FTEs/full time equivalents are associated with the acceptance of this grant; and

WHEREAS, acceptance of the TA grant to support the Purcell Walk Improvements project is in accordance with the "Live" goal to "[c]reate a more livable community" and strategy to "[b]ecome more walkable" as described on pages 156-158 of Plan Cincinnati (2012); now, therefore,

BE IT ORDAINED by the Council of the City of Cincinnati, State of Ohio:

Section 1. That Council authorizes the establishment of new capital improvement program project account no. 980x233x262326, "Purcell Walk PID 122990 Grant," to provide resources for pedestrian improvements in the East Price Hill neighborhood.

Section 2. That the City Manager is authorized to apply for, accept, and appropriate Transportation Alternatives grant resources (ALN 20.205) of up to \$480,000 awarded by the Ohio-Kentucky-Indiana Regional Council of Governments to the newly established capital improvement program project account no. 980x233x262326, "Purcell Walk PID 122990 Grant," to provide resources for pedestrian improvements in the East Price Hill neighborhood.


Section 3. That the Director of Finance is authorized to deposit the grant resources into the newly established capital improvement program project account no. 980x233x262326, "Purcell Walk PID 122990 Grant," to provide resources for pedestrian improvements in the East Price Hill neighborhood.

Section 4. That the City Manager is authorized to do all things necessary to cooperate with the Director of the Ohio Department of Transportation to complete the Purcell Walk Improvements project.

Section 5. That the proper city officials are authorized to do all things necessary and proper to carry out the terms of the grant and Sections 1 through 4.

Section 6. That this ordinance shall take effect and be in force from and after the earliest period allowed by law.


