An Ordinance No._

AUTHORIZING the transfer of the sum of \$700,000 from the General Fund balance sheet reserve account no. 050x2580, "Reserve for Weather Related Events, Other Emergency and One-Time Needs," to the unappropriated surplus of General Fund 050; and AUTHORIZING the transfer of the sum of \$1,152,123 within the General Fund, from and to various operating accounts and the unappropriated surplus of the General Fund according to the attached Schedule of Transfer, for the purpose of realigning and providing funds for the ongoing needs of City departments.

WHEREAS, funding in the amount of \$332,123 within the City Manager's Office for the Cincinnati Citizens Respect Our Witnesses program was appropriated to a personnel operating budget account, but the expenses incurred will be from a non-personnel operating budget account; and

WHEREAS, the Department of Economic Inclusion has a non-personnel need of \$85,000 to replace non-personnel funds that were needed to satisfy leveraged support obligations from FY 2021; and

WHEREAS, the Department of Law has a non-personnel need of \$35,000 related to additional unplanned outside counsel expenses including a contract extension related to the housing court; and

WHEREAS, funding in the amount of \$700,000 is being provided as a supplemental appropriation to the Cincinnati Police Department for additional Police Visibility Overtime to address an increase in violent crime; now, therefore,

BE IT ORDAINED by the Council of the City of Cincinnati, State of Ohio:

Section 1. That the sum of \$700,000 is hereby transferred from the General Fund balance sheet reserve account no. 050x2580, "Reserve for Weather Related Events, Other Emergency and One-Time Needs," to the unappropriated surplus of General Fund 050.

Section 2. That the sum of \$1,152,123 within the General Fund, from and to various operating accounts and the unappropriated surplus of the General Fund, is hereby transferred and appropriated according to the attached Schedule of Transfer for the purpose of realigning and providing funds for the ongoing needs of City departments.

Section 3. That the proper City officials are hereby authorized to do all things necessary and proper to carry out the terms of Sections 1 and 2.

Section 4. That this ordinance shall be an emergency measure necessary for the preservation of the public peace, health, safety, and general welfare and shall, subject to the terms of Article II, Section 6 of the Charter, be effective immediately. The reason for the emergency is the immediate need to allow for the continuation of uninterrupted services in FY 2022.
