Reviews critical areas of law enforcement




Accomplished in January 2020 Regular schedule of re-inspection every 4 years

Offenses Reported to UCPD: Year-to-Date






The CSR Area

CSR: Concentration of Student Residents


 UCPD provides patrols in the area around the university as well as the regional campuses






Serious Person Offenses: Year-to-Date











Serious Property Offenses: Year-to-Date 2020







Burglary CSR: Year-to-Date
