AUTHORIZING the City Manager to accept a grant of up to \$9,500 from the FY 2022 Certified Local Government Grant Program for the purpose of reimbursing costs associated with hosting the National Alliance for Preservation Commission's Biennial Conference Forum in Cincinnati, Ohio in July 2022; AUTHORIZING the City Manager to appropriate the grant resources to the City Planning and Engagement General Fund non-personnel operating budget account no. 050x171x7200; and AUTHORIZING the Finance Director to deposit the grant resources into the Department of City Planning and Engagement General Fund revenue account no. 050x8528.

WHEREAS, on March 9, 2022, Council approved Ordinance No. 0058-2022, which authorized the City Manager to apply for grant resources in an amount of up to \$10,000 from the Certified Local Grant Program, to be used to reimburse costs associated with hosting the National Alliance for Preservation Commission's ("NAPC") Biennial Conference Forum in Cincinnati in July 2022; and

WHEREAS, the Department of City Planning and Engagement was notified of the grant award in an amount of \$9,500; and

WHEREAS, the NAPC Biennial Conference Forum is the only national conference focused on the issues facing local historic preservation boards and commissions, and was cohosted by the City of Cincinnati, the State Historic Preservation Office, Ohio History Connection, and Cincinnati Preservation Association, and attracted approximately 500 participants; and

WHEREAS, no new FTEs or additional local match requirements are associated with this grant because the Department of Buildings and Inspections provided \$10,000 in FY 2022 as a conference sponsorship that fulfilled the grant local match requirement; and

WHEREAS, acceptance of this grant is in accordance with the "Sustain" strategy to "[p]reserve our built history," as described on pages 197-198 of *Plan Cincinnati* (2012); now, therefore,

BE IT ORDAINED by the Council of the City of Cincinnati, State of Ohio:

Section 1. That the City Manager is hereby authorized to accept a grant of up to \$9,500 from the FY 2022 Certified Local Government Grant Program for the purpose of reimbursing costs associated with hosting the National Alliance for Preservation Commission's Biennial Conference Forum in Cincinnati, Ohio in July 2022.

Section 2. That the City Manager is hereby authorized to appropriate the grant resources to the City Planning and Engagement General Fund non-personnel operating budget account no. 050x171x7200.

Section 3. That the Finance Director is hereby authorized to deposit the grant resources into the Department of City Planning and Engagement General Fund revenue account no. 050x8528.

Section 4. That this ordinance shall be an emergency measure necessary for the preservation of the public peace, health, safety, and general welfare and shall, subject to the terms of Article II, Section 6 of the Charter, be effective immediately. The reason for the emergency is the immediate need to accept the grant resources and pay conference invoices in a timely manner.
