Process Overview

- Liquor permits are regulated by the State of Ohio, Department of Commerce, Division of Liquor Control
- Liquors permits are valid for one year must be renewed annually
- City Council has the right to object to the renewal of liquor permits, under R.C. 4303.2929
- Objections are usually on one of two grounds:
 - The permit holders has operated with a disregard of the law
 - The permit location creates a substantial interference with the "public decency, sobriety, peace or good order" with respect to a neighborhood
- City Solicitor must approve the objection as having a legal basis



Process Overview

- After City Council initiates an objection, there is a hearing held by the Ohio Division of Liquor Control - witnesses provide testimony and evidence is presented.
- The permit holder or City may appeal the decision of the Ohio Division of Liquor Control to the Ohio Liquor Control Commission, where another evidentiary hearing is held.
- The permit holder or City may appeal the decision of the Ohio Liquor Control Commission to Frankly County Common Pleas Court



2020 Annual Renewal Objections

- In a regular year, Cincinnati must transmit its objections to the Ohio Division of Liquor Control before May 2.
- At the end of September, the City was notified the deadline for 2020 would be November 1.
- The administration does not have any recommended objections for 2020.
