## An Ordinance No.\_

AUTHORIZING the establishment of American Rescue Plan grant project account no. 469x101xARP016, "CEAI Development Support," for the purpose of providing funds to Community Economic Advancement Initiative ("CEAI") for developmental support in the Bond Hill and Roselawn areas; AUTHORIZING the appropriation of the sum of \$490,000 from the unappropriated surplus of Local Fiscal Recovery Fund 469 to newly established American Rescue Plan grant project account no. 469x101xARP016, "CEAI Development Support," for the purpose of providing funds to CEAI for developmental support in the Bond Hill and Roselawn areas; and further DECLARING expenditures from ARP grant project account no. 469x101xARP016, "CEAI Development Support," to be for a public purpose.

WHEREAS, the City is eligible to receive funding from the United States Department of the Treasury pursuant to the American Rescue Plan Act as part of the Coronavirus Local Fiscal Recovery Fund Act; and

WHEREAS, the Bond Hill and Roselawn areas of the City have experienced substantial businesses losses and suffered other negative economic consequences due to the COVID-19 pandemic; and

WHEREAS, a development support program administered by the Community Economic Advancement Initiative will assist the Bond Hill and Roselawn areas of the City; now, therefore,

BE IT ORDAINED by the Council of the City of Cincinnati, State of Ohio:

Section 1. That the Director of Finance is hereby authorized to establish American Rescue Plan grant project account no. 469x101xARP016, "CEAI Development Support," for the purpose of providing funds to Community Economic Advancement Initiative ("CEAI") for developmental support in the Bond Hill and Roselawn areas.

Section 2. That the sum of \$490,000 is hereby appropriated from the unappropriated surplus of Local Fiscal Recovery Fund 469 to newly established American Rescue Plan grant project account no. 469x101xARP016, "CEAI Development Support," for the purpose of providing funds to CEAI for developmental support in the Bond Hill and Roselawn areas.

Section 3. That expenditures from ARP grant project account no. 469x101xARP016, "CEAI Development Support," are hereby declared to be for a public purpose because providing funds for developmental support in the Bond Hill and Roselawn areas improves the economic and general well-being of the people of the City, which is necessary because of the impacts of the COVID-19 pandemic.

Section 4. That the proper City officials are authorized to do all things necessary and proper to carry out the terms of Sections 1 through 3 hereof.

Section 5. That this ordinance shall be an emergency measure necessary for the preservation of the public peace, health, safety, and general welfare and shall, subject to the terms of Article II, Section 6 of the Charter, be effective immediately. The reason for the emergency is the immediate need to implement authorized American Rescue Plan-related support programs.
