Due to the pandemic, BFR was held virtually in 2020 and will be held virtually again 2021. In order to bring this important event back as a live 3-4 day event in the summer of 2022, the sponsoring organization, I Hear Music, Inc. is requesting \$25,000 from the City to augment the funds that will be raised from the private sector.
