WHEREAS, on December 15, 2021, Council passed Ordinance No. 507-2021, which was amended by Ordinance No. 163-2022, authorizing the transfer and appropriation of \$500,000 from the General Fund to capital improvement program project account no. 980x233x222390, "Red Bike Program Expansion," to provide resources for program expansion into various City neighborhoods, including Bond Hill, Roselawn, Evanston, and Avondale; and

WHEREAS, on March 13, 2024, the Cincy Bike Share Board voted to discontinue operations indefinitely due to lack of sustainable funding; and

WHEREAS, a fundraising campaign has been created to avoid a discontinuation of Red Bike's operations, towards which the City will transfer existing capital funds allocated to Red Bike to the operating budget as the City's contribution to this effort; and

WHEREAS, this funding is intended as a one-time contribution as bridge funding to allow Red Bike to establish a long-term sustainable funding model; and

WHEREAS, providing resources for operating support for Red Bike is in accordance with the "Compete" goal to "[d]evelop an efficient multi-modal transportation system that supports neighborhood vitality" and the strategy to "[e]xpand options for non-automotive travel" as described on pages 127-146 of Plan Cincinnati (2012); now, therefore,

BE IT ORDAINED by the Council of the City of Cincinnati, State of Ohio:

Section 1. That the transfer and return to source of \$197,197.76 from capital improvement program project account no. 980x233x222390, "Red Bike Program Expansion," to the unappropriated surplus of General Fund 050 is authorized.

Section 2. That \$197,197.76 is transferred and appropriated from the unappropriated surplus of General Fund 050 to the Department of Transportation and Engineering FY 2024

non-personnel operating budget account no. 050x232x7200 to provide one-time resources for operating support to allow Red Bike d/b/a Cincy Bike Share, Inc. to continue to operate in the City.

Section 3. That the proper City officials are authorized to do all things necessary and proper to carry out the terms of Sections 1 and 2.

Section 4. That this ordinance shall be an emergency measure necessary for the preservation of the public peace, health, safety, and general welfare and shall, subject to the terms of Article II, Section 6 of the Charter, be effective immediately. The reason for the emergency is the immediate need to deploy funding to allow Red Bike to continue operations.

Subject: Hillside Overlay District Issue Spotting

Reference Document #202301262

The Climate, Environment & Infrastructure Committee, at its session on May 9, 2023, referred the following item for review and report:

MOTION, submitted by Councilmember Jeffreys, WE MOVE that the Administration report within thirty (30) days on the status of the updates the City is making to its hillside regulations. This update should include, but is not limited to, an update on:

- Funding sources to cover construction mishaps associated with construction within the hillside district.
- Regulations associated with stormwater runoff.
- Work that is being done to update CAGIS' Hillside Overlay District Map.

ORIGINS AND VALIDITY OF THE CAGIS HILLSIDE OVERLAY DISTRICT MAP

The CAGIS Hillside Overlay District Map was created and last updated in 2004 at the time of the adoption of the most recent Zoning Code. This map shows those areas of the City where the Hillside Overlay District regulations apply. The regulations guide development in existing hillside areas to ensure it is compatible with the natural environment and a quality urban environment. The regulations are especially focused on locations where the hillsides are of significant public value as determined by the City policy as outlined in the document "A Hillside Protection Strategy for Greater Cincinnati," 1991.

The Hillside Overlay District layer on CAGIS is typically applied to hillside areas where the existence of a 20% slope is combined with the KOPE geologic formation, the shale bedrock that is overlaid by colluvial soils. The layer was created through a digitization of the 1980 "Landslide Susceptibility Study and Map" prepared in 1980 by the consulting firm of Sowers and Dalrymple for the Department of Transportation and Engineering. This map divides the City of Cincinnati into four categories of landslide susceptibility: low, moderate, moderately high, and high. Most areas categorized as moderately high and high are included in the boundaries of the Hillside Overlay Districts. The map is also used by the Department of Buildings and Inspections to determine the need for further geotechnical investigation, requiring geotechnical involvement in areas categorized as moderately high and high.

This study is still considered to be an accurate portrayal of the landslide susceptibility in Cincinnati. If it is determined that further review of the 1980 Landslide Susceptibility Study and Map is warranted, allocation of funds to retain a consultant to perform this work is required.

FUNDING SOURCES

The City does not currently provide funding for construction mishaps associated with private development on private properties - either in a hillside area or otherwise. The Administration does not recommend committing public funds to this purpose and instead recommends focusing on updating or creating appropriate regulations to address the risk.

HILLSIDE DEVELOPMENT REGULATIONS

Buildings & Inspections (B&I) convened several meetings of City agencies that regulate development of landslide prone properties, mostly found within Hillside Development Overlay zoning districts. The group identified multiple challenges with management of development within the landslide prone areas. These are summarized below:

- The Zoning Code presently expresses most of the City's aspirations and requirements for development on hillsides. While a GIS layer is a good tool to establish heightened development regulations, and zoning overlays are effective for guiding a community's design preferences for development, the zoning code is ill-suited to establish the associated construction standards and making engineering determinations.
- Damages from landslides are hard to predict, can be financially calamitous to the City and
 affected property owners, and nearly impossible to insure. A key consideration is to what
 degree the City should consider preventative strategies, including further studying our
 landslide susceptibility, preventing poor land management practices like clear-cutting,
 requiring notice of landslide susceptibility with deeds and property documents, and weighing
 whether some land is simply not suitable for development.
- Hillside-area specific minimum engineering and building standards do not currently exist and should be created to provide clear standards for hillside development.
- Best practices in mitigation of hillside development risks necessitate a closer examination of the management of stormwater, and the effectiveness and enforcement systems of current stormwater management regulations. This includes examining regulations regarding vegetation and clear-cut management, maximum impervious surface coverage, detention triggers on development and re-development, and detention design requirements.

Given the complexity of these interwoven challenges and the high potential for extensive impacts on development costs and patterns, the Administration proposes to undertake a long-term initiative to update associated law and regulation. Given the multi-department and even multi-government nature of this initiative, the need for extensive community engagement and iteration, and available resources for overseeing such an initiative, this process is expected to take one to two years. However, work is already underway on opportunity identification and changes will be rolled out and implemented throughout this long-term process, as to create more short-term improvement. The Administration will provide periodic updates to Council on the progress.

The City Council at its session on September 13, 2023, adopted the following item:

MOTION, submitted by Vice Mayor Kearney, WE MOVE that the Department of Planning and Community Engagement waive the \$1,500 fee for First Baptist Church of Walnut Hills' application for historical landmark designation.

The Department of City Planning and Engagement oversees the City's urban planning functions, including the development and implementation of city and neighborhood plans and the development and oversight of amendments to the City's official zoning map. Changes to the zoning map are more commonly known as "zone changes." Zone changes may have many effects, including: (i) allowing a single parcel or several adjacent parcels to be used for a newly proposed land use, (ii) designating an area of adjacent parcels for desired future land uses, (iii) applying an overlay district over an area to provide special rules or protections (e.g., hillside or interim development control districts), or (iv) protecting a historic landmark or district.

The application for most zone changes has a fee of \$1,500, and certain specialized zone changes may have higher fees. These generally applicable fees cover a portion of the cost for staff time from the Department of City Planning and Engagement, the Law Department, and any other departments involved in the zone change process; printing and mailing of public notices; and any printing or other costs associated with the review of the application. All applicants are required to pay the application fee in order for the application to be deemed complete; however, an effective exemption from this fee is currently available if a City Councilmember agrees to sponsor the application of a community group as his or her own legislative proposal.

Community organizations frequently raise concerns that the City's application fees are prohibitive. They believe the fee makes it difficult for neighborhood leadership to proactively pursue the designation of potentially historic landmarks and districts, pursue zoning studies, or implement zone changes recommended in Neighborhood Plans. However, as noted, fees are an important source for recovering costs the City incurs in connection with the zone change process, and these fees are charged equally to all applicants because those costs are not otherwise budgeted.

In September 2023, Cincinnati City Council adopted the above Motion and Vice Mayor Kearney became a co-applicant for the application for the historic landmark designation of the First Baptist Church of Walnut Hills. Several City Council members requested that the City Administration propose a more permanent and sustainable solution to this issue.

The Department of City Planning and Engagement and the Law Department collaborated to consider a legally defensible solution. A preferred solution would balance the Administration's workload with the ability for recognized community organizations to pursue map and text amendments for the benefit of their community. To balance the competing interests outlined above, the Department of City Planning and Engagement will build into its annual work plan a number of zone changes in each calendar year. These zone changes, including the creation of historic landmarks and districts, may be requested by a recognized community organization (such as a Community Council or Community Development Corporation) as an initial means to implement an approved neighborhood plan or as part of a neighborhood plan process.

Zone changes under these circumstances would be provided at no cost to the requestor because they would be treated as part of the department's ordinary long-range planning process and not as one-off zone-change applications. Zone changes implemented through this process have the additional benefit of having been initially assessed by the City Planning Commission and City Council due to their inclusion in an approved city or neighborhood plan. Finally, this process will help communities implement their neighborhood plans while ensuring that the Department of City Planning and Engagement appropriately budgets within its administrative and operational capacity and costs to ensure its continued delivery of superior public services.

Also, this proposal would not remove the option for Council members to be co-applicants for other desired amendments not reflected in a Neighborhood Plan.

RECOMMENDATION

Beginning with the 2025 budget cycle, the Department of City Planning and Engagement will implement this process change by developing an annual work plan that incorporates a number of zone changes annually to implement this community plan-oriented approach within the department's long-range planning processes.

AUTHORIZING the City Manager to apply for, accept, and appropriate a grant of up to \$1,814,329 from the U.S. Department of Homeland Security, Federal Emergency Management Agency, FY 2023 Assistance to Firefighters Grant Program (ALN 97.044) to provide resources for the purchase of a heavy rescue apparatus and for professional development training for career firefighters; and **AUTHORIZING** the Director of Finance to deposit the grant resources into Fire Grants and Donations Fund 472, revenue account no. 472x8542.

Approval of this Ordinance would authorize the City Manager to apply for, accept, and appropriate a grant from the U.S. Department of Homeland Security (DHS), Federal Emergency Management Agency (FEMA), FY 2023 Assistance to Firefighters Grant Program, (ALN 97.044) of up to \$1,814,329 to provide resources for the purchase of heavy rescue apparatus and for professional development training for career firefighters. This Ordinance further authorizes the Finance Director to deposit grant resources into Fire Grants and Donations Fund 472, revenue account no. 472x8542.

CFD will utilize grant resources to purchase a heavy rescue apparatus and cover backfill overtime for firefighters receiving professional development training through the CFD Officer Training Program or the CFD Fire Apparatus Operator Professional Development Course.

Acceptance of this grant requires a local cost-share match of \$164,940. \$120,624 of the local match will be provided from existing capital improvement program project account no. 980x272x242704, "Fire Equipment," and will be used to provide fire equipment necessary to outfit the heavy rescue apparatus. MOTION

WE MOVE that Cincinnati City Council reallocate and approve the transfer of one million dollars (\$1,000,000) from the Housing Stability Capital Account to the General Fund to provide payment assistance to eligible Cincinnati homeowners for past due property taxes for owner-occupied 1-4 family residences.

To qualify for assistance, the applicant-homeowner's residence must be located within the City of Cincinnati, the residence must be the applicant-homeowner's primary residence, and the applicant-homeowner's household must have an annual income at or below 80% Area Median Income (Ex. Annual income of \$65,040 or below for a family of four).

Given that these are emergency funds, we ask the administration to develop a streamlined 10-day process for application to receipt of funds. In addition, we ask for recommendations for a source of ongoing funding to assist with payment of delinquent property taxes in the future to prevent our low- and moderate-income families from losing their homes.

STATEMENT

Many of our low- and moderate-income residents are struggling financially due to recent increases in property taxes. According to the Hamilton County Recorder's Office, delinquent property taxes in the City of Cincinnati currently total approximately \$3.2 million. The Attachment to this Motion shows a neighborhood breakdown of delinquent property taxes. Our goal is to keep residents in their homes and prevent them from having to choose between paying for their homes and purchasing other necessities of life.

A recent article in *The Cincinnati Enquirer* reported that there has been a historic 34 percent increase in residential property values in Hamilton County, and an overall 15 percent increase in property taxes. "But in some neighborhoods – especially in some poor and working-class neighborhoods in the city of Cincinnati – the tax increase nearly matched the hike in values, making those some of the unluckiest homeowners in Hamilton County." (*Ohio homeowners reeling from Hamilton County's new property values*, cincinnati.com, Feb. 13, 2024) "Statewide, the poorest fifth of Ohio homeowners pay more than triple their share of income in property taxes compared to the richest 1% of homeowners, according to the Institute on Taxation & Economic Policy, a Washington D.C.-based think-tank."

Councilmember Jeffreys has convened a task force that will look at recommendations and possible solutions for the rising property taxes that are affecting our residents, while keeping in mind, tax rates are set by the State of Ohio, and not the City of Cincinnati.
