The Greater Cincinnati Foundation is providing the training to the City at no cost and can accommodate up to 50 participants. WE FURTHER MOVE for the city administration to urge all department heads to participate and to select a designee(s) to attend along with them. The following report provides an update by the Administration regarding future participation in the Greater Cincinnati Foundation's Groundwater and Phase 1 trainings.

The Greater Cincinnati Foundation (GCF) coordinates a training series conducted by the Racial Equity Institute focused on creating racially equitable organizations. The Groundwater session teaches attendees about racial equity and systemic racism while serving as an introduction to the Phase 1 two-day workshop covering historical, cultural, and structural analysis of racism.

The Administration has tentatively scheduled a half-day Groundwater session for senior level staff on Thursday September 30, 2021. We are awaiting confirmation from the GCF for this proposed date, along with Phase 1 series dates.




