4. 202103114 MOTION, submitted by Councilmembers Seelbach and Young, WE MOVE that the Administration convert the underutilized block of W 12th, between Central Ave & Central Parkway to long term metered parking at the same rate structure as the adjacent parking in existence on Central Ave, for the purpose of providing price sensitive workers & visitors increased parking options while better utilizing a city asset. This block of Parking in the West End adjacent to Over-the-Rhine has one of the lowest meter utilizations in the greater Downtown area, at below 15% utilization on average, as compared with the national standard goal of 85% utilization (for comparison, Vine Street often surpasses 90% utilization). Providing price sensitive low & moderate wage workers and guests an appropriately priced long term parking solution in a low demand area will increase overall meter utilization & provide diverse parking options for the urban core.

WHEREAS, after leaving City Hall, Dr. Reece founded Communiplex as an advertising, marketing, and promotions company and was a founding member of the first African American Chamber of Commerce in Cincinnati; and

WHEREAS, for over 20 years, Integrity Hall remained an entrepreneurship center for Black businesses, hosting over 3,000 events, including banquets, weddings, receptions, seminars, family reunions, private parties, and rallies, which included three presidential rallies; and

WHEREAS, Dr. Steven Reece Sr.'s contributions and dedication to the City of Cincinnati and its citizens will long be remembered; now, therefore,



**DECLARING** that the portion of Harrison Avenue located between Queen City Avenue and Westwood Avenue in the South Fairmount neighborhood shall hereby receive the honorary, secondary name of Moon Tree Bridge in memory of the Moon Tree, a large sycamore tree descended from seeds carried on the Apollo 14 mission to the moon and planted in the South Fairmount neighborhood.

WHEREAS, in 1971, the Apollo 14 mission travelled to the moon carrying tree seeds that were later planted around the county and grown into trees known as "moon trees"; and

WHEREAS, Mr. Dennis Smith planted a descendant of the moon trees on his property, and it grew to be a large sycamore tree known locally as the "Moon Tree"; and

WHEREAS, the Moon Tree became a prominent landmark in the South Fairmount neighborhood, was well-known among members of the community, and was recognized as a second generation moon tree by NASA; and

WHEREAS, the Moon Tree was removed due to construction constraints associated with the Lick Run Project, but clones of the original Moon Tree have since been planted around the Lick Run; and

WHEREAS, the original Moon Tree has important historical and educational significance to the local community and local schools; and

WHEREAS, the City wishes to recognize the historical and educational importance of the Moon Tree and the Apollo moon missions by bestowing the honorary, secondary name of Moon Tree Bridge on the portion of Harrison Avenue located between Queen City Avenue and Westwood Avenue; now, therefore,

BE IT ORDAINED by the Council of the City of Cincinnati, State of Ohio:

**DECLARING** that Considine Avenue at the intersection with Warsaw Avenue in the East Price Hill neighborhood shall hereby receive the honorary, secondary name of "Sergeant Charles F. Handorf Memorial Way" in memory of Cincinnati Police Sergeant Charles F. Handorf and in recognition of his service to the City of Cincinnati.

WHEREAS, Charles Francis Handorf was the eldest of fifteen children born to Charles and Rose Handorf; and

WHEREAS, Sgt. Handorf attended Roger Bacon High School, but withdrew his senior year due to his father's illness and later completed his studies at Hughes Night School, graduating in June 1946; and

WHEREAS, Sgt. Handorf joined the Cincinnati Police Department in 1952, where he served with honor and distinction and was awarded several promotions during his time on the force; and

WHEREAS, among others, Captain Clem Merz, District Four Commander, considered Sgt. Handorf to be one of the most reliable men in the district; and

WHEREAS, in 1957, Sgt. Handorf was shot in the stomach, requiring six hours of surgery and a long recuperation period, but thereafter he returned to duty; and

WHEREAS, prior to becoming a sergeant, Charles Handorf next worked in Investigations and was encouraged by his superiors to pursue the rank of sergeant; and

WHEREAS, in 1960, based on competitive examination, Charles Handorf was promoted to detective and transferred to the Crime Bureau; and

WHEREAS, in 1961, following a subsequent exam, then-Det. Handorf was promoted to sergeant and was selected to attend the prestigious three-month Administrative Officers Course at the Southern Police Institute at the University of Louisville, a rare honor for a newly promoted sergeant; and

WHEREAS, in February 1966, Sgt. Handorf was transferred to Vice Control Bureau; and

WHEREAS, in October 1966, Sgt Handorf was placed in command of the District Three Tactical Unit; and

WHEREAS, on December 7, 1974, Sgt. Handorf completed his tour of duty with his tactical unit at 11 p.m.; and

WHEREAS, at 12:15 a.m. on December 8, 1974, while completing paperwork, a call for help came in, to which Sgt. Handorf responded, though off-duty, out of a sense of responsibility as a leader of his fellow officers; and

WHEREAS, Sgt. Handorf tragically lost his life while responding to the call; and

WHEREAS, Sgt. Handorf was caring, competent, and well regarded by his fellow officers and the citizens of Cincinnati, so much so that the citizens and the Price Hill neighborhood placed a plaque at the base of the flagpole at the location of the Old District Three headquarters; and

WHEREAS, Sgt. Handorf was a great "street cop" and kept a poem in his locker titled, "The Indispensable Man," to remind himself that no one is indispensable; and

WHEREAS, Sgt. Handorf loved his two daughters and his family and was also a dedicated son, brother, and leader at the Cincinnati Police Department; and

WHEREAS, the City of Cincinnati wishes to remember those who have given their lives in the line of duty so they will never be forgotten; now, therefore,

BE IT ORDAINED by the Council of the City of Cincinnati, State of Ohio:
