ORDINANCE (EMERGENCY) submitted by Paula Boggs Muething, City Manager, on 5/11/2021, **AUTHORIZING** the establishment of American Rescue Plan grant project account no. 469x101xARP053, "Hazard Pay," for the purpose of providing additional compensation to employees during the COVID-19 pandemic; and AUTHORIZING the appropriation of the sum of \$2,800,000 from the unappropriated surplus of Local Fiscal Recovery Fund 469 to newly established American Rescue Plan grant project account no. 469x101xARP053, "Hazard Pay," for the purpose of providing additional compensation to employees during the COVID-19 pandemic; and DECLARING expenditures from American Rescue Plan grant project account no. 469x101xARP053, "Hazard Pay," to be for a public purpose.
