Title: MOTION, submitted by Councilmembers Keating, Jeffreys, Cramerding, Johnson, Owens, Harris and Kearney, WE MOVE that Cincinnati City Council adopt the Rules of Council from the immediate past council as last amended on September 27, 2017, until Council adopts new rules or further revises those adopted today excluding the following: The following changes of Section 10.1 - 10.1 Appointment of Committees. The standing Committees and vice-chairs shall be appointed by a vote of a majority of the Members. The chairs of the standing Committees shall be appointed by the Mayor. There shall be at least three members on each Committee. Every Member shall serve on at least three one Committees that meets regularly. Members shall be given the right to serve on Committees of their choosing. So long as a Member serves on at least three one Committees that meets regularly, such Member shall not be required to serve on a Committee that the Member has not requested to be a Member of. In cases in which a Committee has fewer than three Members, the Presiding Office of the Committee shall request after Members to join the Committee. If membership on the Committee remains below three, the Rules and Audit Committee Council may disband and apportion the responsibilities of the disbanded Committee to the other Standing Committees, subject to the approval of Council.
